## **Course Description:**

This course uses microeconomic theory and statistical analysis to study labour markets. It focuses on decisions made by workers, firms and governments. Key topics include earnings inequality, discrimination, human capital accumulation, migration, and social interactions in the labour market.

#### **Course Learning Outcomes:**

Students who successfully complete this course will:

- Understand and be able to explain the key determinants of labour supply. This includes being familiar with the substitution and income effects of wage changes and the distinctions between static and dynamic labor supply in a life-cycle framework. Students should be able to use a model of labor supply to analyze the potential effect of public policies such as income taxes, child care subsidies or mandatory retirement age rules on labour force participation.
- 2. Understand and appreciate how labour demand derives from the demand for goods and services.
- 3. Know and understand the implications for wages of market power in the labour market. Students can explain how wages and employment differ in monopsonies, in contrast with competitive labour markets. Know and understand how labour supply and labour demand interact in equilibrium. Students possess a deep understanding of the benchmark case of perfect competition and are able to describe the theoretical results it generates regarding minimum wage policies.
- 4. Understand and appreciate the key principles of optimal investments in human capital, and the implications of Canadian education policies for wage inequality.
- 5. Understand the impact of immigration on labour markets and know the key associated empirical results.
- 6. Understand and know the differences between taste-based and statistical discrimination and the methods used to evaluate the amount of discrimination in the Canadian labour market. Students should be familiar with key facts such as earnings differentials between genders and between immigrants and non-immigrants.
- 7. Understand and appreciate the principal-agent framework as well as the design of optimal compensation systems based on economic incentives.

- 8. Know and understand the basic Canadian institutions related to unionization as well as the notion of collective bargaining.
- 9. Develop the skills necessary to conduct a critical assessment of economics research papers and economic news reporting. This includes reviewing relevant literature, and communicating results. Included in this outcome are professional skills developed by giving written feedback on others' work.

If a student's letter grade on the final exam exceeds their midterm(s) letter grade, the weight of the midterm(s) may be transferred to the final exam at the discretion of the instructor. The student must have written the midterm(s) or provided supporting documentation for the absence(s) such as a medical note or statutory declaration.

Course material dealing with a particular assignment will typically be covered in class at least 1 week before the assignment is due; thus, assignments can be completed at any time up to and including the due date. Given these factors, only situations where someone can document illness or domestic affliction for an extended period (i.e., the entire week prior to the due date) would possibly warrant shifting the assignment weight to the final exam. Furthermore, technical problems can be expected to occur with computer systems (and internet availability) so it may be a good idea to not wait until the last minute to submit your assignment.

The midterm exam(s) is take-home exam(s) designed and intended to be completed in 75 minutes. The exam(s) will be open book. The exam(s) will be available on D2L. Student will download the exam from D2L, complete the exam, scan it, and submit using Dropbox in D2L. Student will have 50% time extension to complete the exam, at a time of your choosing, within a 24-hour period determined by the instructor.

The final examination will be take-home, comprehensive, and scheduled by the Registrar. Students will download the exam from D2L, complete the exam, scan it, and submit using Dropbox in D2L. Student will have 50% more time to complete the exam, at a time of their choosing, within the 24-hour period that begins 24 hours before the end date of the Registrar's scheduled final exam for this course. The exam is designed and intended to be completed in two hours. The exam will be open book.

All other course components will also be accessed, submitted, and returned through D2L.
