#### **Course Content:**

The course will examine selected economic issues in water resource systems in Canada and other countries, including water quantity, water quality, ecosystem sustainability and water supply.

#### (a) <u>Examinations</u>

The midterm examination will be held in class on a date to be announced. The Final Examination will be scheduled by the Registrar and will last two hours. It will be a comprehensive examination of all material covered in the course. All examinations will be closed-book. Students will *not* be allowed the use of calculators or other aids during any examination.

Deferred examinations will not be given *except in the case of the Final Examination, where this possibility is provided for in the university's Academic Regulations*. Examinations will not be given *before* the indicated examination date. For further information see the 2014/2015 *Calendar*.

# (b) <u>Term Paper</u>

Students are encouraged to choose a specific and well-defined topic of interest based on the course content and to prepare a relatively short and concise paper. The topic for the paper must be cleared with the Instructor no later than February 20, and the paper will be due on April 8. Additional information about requirements for the term paper will be provided to students during the first weeks of class.

# (c) <u>Scheduled Laboratory Sessions</u>

This course has a scheduled lab session each Tuesday that will be used for such activities as viewing films, hearing from guest speakers, class discussion, and so on. Some of these activities will involve short assignments, participation and exercises that will count towards your course score.

# (d) <u>Course Grades</u>

A numerical score will be determined for each item of work submitted and a final (weighted) percentage score will be determined. A course letter grade will be assigned based upon the following conversion chart for final percentage scores:

A passing grade on any particular component of the course is <u>not</u> required for a student to pass the course as a whole.

Students seeking reappraisal of a piece of graded term work (including the midterm exam) should discuss their work with the instructor *within fifteen days* of it being returned to class.
