Course Description:

This course uses economic theory (building on Econ 357) and economic statistics (building on Econ 395) to understand the organization of production, distribution, and exhibition in the motion-picture industry. The primary focus of the course is on the economics of contracts – in particular how information and uncertainty shape the structure of economic transactions. The historical and institutional illustrations, as well as the more detailed empirical analyses, are set in the context of Hollywood.

Course Learning Outcomes:

Students who successfully complete this course will:

- 1. Learn to apply intermediate microeconomic theory at the level of ECON 357 and basic economic statistics at the level of ECON 395 to understand the organization of the motion-picture industry.
- 2. Learn and be able to explain how information and uncertainty shape the structure of economic transactions with particular reference to the motion-picture industry.
- 3. Learn to analyze the business practices that have evolved in the motion-picture industry, including but not limited to block booking, blind bidding, master license agreements, and temporal and geographic clearances.
- 4. Learn statistical tools that are particularly useful in analyzing data and making inferences in a market dominated by `superstars' in which the outcome distribution has a winner-take-all characteristic.
- 5. Learn to distinguish between competing models of demand dynamics through the examination of the outcome distribution.
- 6. Learn conceptual and empirical techniques to quantify the impact of counterfeiting and piracy on the entertainment industry.
