Course Outline:

This advanced undergraduate course in Economics will focus on contemporary issues in international trade policy.

Economics 357 and 359 are required prerequisites. Economics 321 and/or 425 are useful for background, but not required.

The course will be conducted on a predominantly independent study basis, but there will be at least two meetings to discuss course material. The first meeting will be an introduction and overview and the second will be a discussion of the use of game theory to analyze international trade policy. Students should schedule these meetings with the instructor for early in the term.

1. **Breadth Components:** There will be an assignment that focuses on the game-theory-understanding of the conduct of international trade policy in chapter 6 of the Kerr and Gaisford *Handbook*. The Assignment will be due November 10.

In addition to the assignment, there will be 12 (twelve) 600-word reading summaries (approximately two double spaced pages). The summaries, which will be based mainly on the chapters in the *Handbook*, should highlight the main themes and issues arising from the readings. The entire *Handbook* will be covered by the summaries and assignment. Details and due dates for the 12 summaries are as follows:

- S1 *Handbook*, Chapters 1-5, due November 10.
- S2 *Handbook*, Chapters 39 and 40, due on or before November 10.
- S3 James Gaisford (2010) "From Kyoto to Copenhagen: Meeting the Climate Change Challenge," *Estey Centre Journal of International Law and Trade Policy*, **11** (1). Article and Technical Annex available on Blackboard. Due on or before November 20.
- S4 *Handbook*, Chapters 8-12, due on or before November 20.
- S5 *Handbook*, Chapters 13-15 and 45, due on or before November 30.
- S6 *Handbook*, Chapters 16-21, due on or before November 30.
- S7 *Handbook*, Chapters 22-25, due on or before November 30.
- S8 *Handbook*, Chapters 26-31, due on or before November 30.
- S9 *Handbook*, Chapters 32-35, due on or before December 10.
- S10 *Handbook*, Chapters 36-38, due on or before December 10.
- S11 *Handbook*, Chapters 41-44, due on or before December 10.
- S12 *Handbook*, Chapters 46-48, due on or before December 10.
2. **Depth Components:** There will be a 5000-word term paper (approximately 15 double spaced pages). The term paper will be due December 20. Topics will typically be chosen from: (a) issues concerning trade and the environment, (b) international trade disputes or (c) other areas of interest in the readings.

Students will be required to submit a proposal by November 20. Proposals will consist of: (a) a topic paragraph, (b) a provisional outline (in clear point form), and (c) a preliminary reference list (with at least five scholarly references and one-sentence annotations).
