Course Description:

This course is part of a two course graduate sequence in international trade. Research in the field of international economics emphasizes both theoretical work and empirical analysis. This course will focus on international trade policy with an emphasis on the theoretical and empirical literature related to trade policy. We will examine important longstanding as well as contemporary issues in the empirical literature of international trade.

The course will be conducted as a seminar and will require class participation and involvement including class presentations.

Course Objectives/Learning Outcomes:

The course objectives are to develop empirical skills and research skills in order to produce research papers with a focus on empirical international trade. By the end of the course students will be well versed in how to start a research project and develop it into a final product. Students will also learn about data sources and analytical techniques related to empirical international economics.
