Course Description

The objective of this course is to introduce you to the study of macroeconomics at the advanced level. This means that we will use rigorous models and employ dynamic optimization techniques to present and analyze macroeconomic theories. Topics will include basic facts of economic growth and long-run economic development; Solow growth model; dynamic programming; basic neoclassical growth model.

Course Outcomes:

On successful completion of this course, students will be able to:

- Cross the gap between undergraduate textbooks in macroeconomics and the modern literature that features dynamic models built upon microeconomic foundations and rational expectations.
- Understand the neoclassical growth model-the workhorse of modern macroeconomic.
- Learn how to use key methodological tools in modern dynamic macroeconomics.
- Establish a strong foundation for further study of modern macroeconomics.
