## **Course Description:**

This is a first-year graduate course covers the theoretical underpinnings of identification, estimation and inference in modern micro-econometrics. The course is divided into two parts. The first part provides a review of probability theory and mathematical statistics. Topics covered will include expectation and conditional expectations; families of distributions and transformations; statistical theory, and the fundamental results of asymptotic theory that underlie identification and inference in modern econometrics. The second part of the course will be devoted to estimation and testing procedures. This section will mainly focus on the Ordinary Least Squares Estimator (OLS), The Maximum Likelihood Estimator (MLE) and the Generalized Method of Moments (GMM). We will discuss the assumptions that underlie each and their resulting finite sample and asymptotic properties. If time permits, the course will end with a brief introduction to nonparametric regression and density estimation.

## **Course Objectives/Learning Outcomes:**

By the end of the course, students will have a strong understanding of the theory that underlies the most commonly applied estimation techniques in econometrics. Students will be able to not only use "pen and paper" to derive properties of estimators but will be able to use computational methods to evaluate the estimators.
