Course description:

No pre-requisites. Does a text ever exist independently from its cultural context? In this course we will examine the ways in which authors respond to one another and how their works relate to cultural and ideological moments in history. Students will look at intertextuality, how narrative is structured and how narratives change within authorial conversations. We will discuss elements of writing including voice, perspective and form in order to answer questions like: who shall participate in society? who shall have public power? whose interests in society shall be recognized and served? How do we use existing texts or ideologies to create a conversation between works? This course will emphasize fundamental skills such as: close reading of literary texts; critical analysis; tools for writing logically, clearly, and correctly; and research skills.

Assignments and Evaluation:

2 in-class group presentations—15% each (total 30%)

Essay #1—10%

Essay#2—15%

Final Essay—20%

Final Exam—15%

Participation—10%

Presentations: for each presentation students will prepare a 10-15 minute presentation in small groups on one of the assigned texts you will sign up for in class. Focus on formulating a thesis statement and finding supporting evidence. Presentations will lead into your essays. More information will be given in class.

Essay #1: 500 words due one week after your first presentation. This essay is a plan for a longer essay based on the feedback from your first presentation. This assignment will consist of an introduction, a thesis statement, topic sentences for your body paragraphs, supporting quotations and a works cited. MLA format, double spaced. Papers must be submitted to me (in hard copy—no electronic submissions) in class. If you are unable to make it to class, papers can be taken to the English office and dropped off before 4:30 that day.

Essay #2: 750-1000 words due one week after your second presentation. This is essay is a complete essay based on the feedback from your second presentation. MLA format, double spaced. Papers must be submitted to me (in hard copy—no electronic submissions) in class. If you are unable to make it to class, papers can be taken to the English office and dropped off before 4:30 that day.

Final Essay: 1000-1250 words. Full essay on two of the works covered in class. You may use one of the texts covered in your first two essays. MLA format, double spaced. Papers must be submitted to me (in hard copy—no electronic submissions) in class. If you are unable to make it to class, papers can be taken to the English office and dropped off before 4:30 that day.

Final Exam: a registrar scheduled exam during the final exam period consisting of passage analyses of works covered in class. Students must be available for examinations up to the last day of the examination period (Dec. 8-18).

Participation: participation marks are earned by coming to class and being prepared to discuss and engage with the works we are studying in class.

Students must complete all assignments in order to receive a passing grade in the course. Please read the attached statement on plagiarism.

Assignments submitted after the deadline will be penalized with the loss of a third of a grade (an A- to B+) for each business day [not class] that the assignment is overdue.

Please make every effort to take assignments directly to the instructor. If it is not possible to do so, take your assignment to SS 1152 and put it in the dropbox. Your assignment will be date-stamped and placed in the instructor's mailbox. It is your responsibility to keep a copy of all assignments in case of loss by any cause. Assignments cannot be returned by staff in the Department office.

Grading system:

Assignments will be graded according to the University's official grading scheme and the English Department's conversion chart, summarized below.

Essays and presentations will be graded according to the standardized departmental letter grades.

The Final Exam will receive a numerical grade, to be converted to a letter grade using the following scale

PLAGIARISM

Plagiarism is an extremely serious offence. Please read the following information carefully. The penalty routinely recommended by the English Department for documented plagiarism is failure of the course in which the offence occurred; academic probation is also routinely applied at the Faculty level. Suspension or expulsion can result from severe or repeated plagiarism.

The University Calendar states:

1. Plagiarism - Essentially plagiarism involves submitting or presenting work in a course as if it were the student's own work done expressly for that particular course when, in fact, it is not. Most commonly plagiarism exists when:

- (a) the work submitted or presented was done, in whole or in part, by an individual other than the one submitting or presenting the work (this includes having another impersonate the student or otherwise substituting the work of another for one's own in an examination or test),
- (b) parts of the work are taken from another source without reference to the original author,
- (c) the whole work (e.g., an essay) is copied from another source, and/or,
- (d) a student submits or presents work in one course which has also been submitted in another course (although it may be completely original with that student) without the knowledge of or prior agreement of the instructor involved.

While it is recognized that scholarly work often involves reference to the ideas, data and conclusions of other scholars, intellectual honesty requires that such references be explicitly and clearly noted.

Plagiarism occurs when direct quotations are taken from a source without specific acknowledgement, or when original ideas or data from the source are not acknowledged. Citing your sources in a bibliography is not enough, because a bibliography does not establish which parts of a student's work are taken from other sources. MLA (Modern Language Association) documentation or other recognized forms of citation must be used for this purpose. Advice on adequate documentation can be found at the following web sites:

DEPARTMENT OF ENGLISH STATEMENT ON PRINCIPLES OF CONDUCT

According to the University Calendar, (<http://www.ucalgary.ca/pubs/calendar/current/j.html>)

“The University of Calgary community has undertaken to be guided by the following statements of purpose and values: to promote free inquiry and debate, to act as a community of scholars, . . . , to respect, appreciate, and encourage diversity, [and] to display care and concern for community”.
