Course description: This course examines how works of literature can respond to different forms of social unrest. Through close readings and critical examinations of a variety of texts, students will develop an understanding of how literary representations of social unrest can address broader social concerns including those associated with race, class, gender, war, agency, colonization, social justice, and ecological catastrophes. This course emphasizes the development of fundamental skills in critical reading and writing. Prerequisites: none.

First essay:

On September 23rd I will distribute a list of essay topics to choose from, each of which will relate to one or more of the assigned course readings. Your essay of approximately 1,000 words will respond to one of these topics by developing an analytical argument about a particular aspect of the relevant text(s). During our class on September 25th I will provide instructions and strategies for writing a scholarly essay on literature, and several times

throughout the course we will engage in writing and analysis activities to help you gain familiarity with the expectations and processes of writing a scholarly essay. Make sure to apply the lessons from these classes to your essay. I will of course also be happy to help you with the process of selecting and developing a topic during my office hours. Bring your completed essay to class on October 16th.

In-class writing assignments:

There will be two graded in-class writing assignments. The first one, on November 6th, will ask you to write on *July's People*, and the second, on November 25th, will ask you to write on *Seeds*. In both cases the specific topic will be distributed in class on the day of the assignment. You will have 45 minutes to prepare and write your response in the form of a short essay. Make sure to write clearly.

Term paper:

On November 6th I will distribute a list of topics for the term paper. This assignment affords an opportunity to build on the writing and analytical skills that you put into practice for the earlier essay, and also gives you the chance to improve on any problem areas. Make sure to pay attention to the feedback provided on your first essay, as well as the writing and argumentation suggestions that I offer to the group throughout the semester. Bring your completed essay of approximately 1,200 words to class on December 4th.

Final exam:

This course will have a written final exam, to be scheduled by the university Registrar's office (the exam period runs from December 8th to 18th). Students must be available for examinations up to the last day of the examination period. This exam is a closed-book exam which will ask you to analyze various aspects of the course content, including material from the lectures as well as from the assigned readings. During our final classes on December 2nd and 4th I will provide a detailed explanation of the format of the exam, and offer advice for the best ways to prepare.

Other notes on evaluation:

There will be no extra-credit assignments, and there is no specific assignment that must be completed to receive a passing grade on the course. Writing and the grading thereof will be a factor in all of the graded components.

Assignments submitted after the deadline will be penalized with the loss of a third of a grade (an A- to B+) for each business day (not class) that the assignment is overdue, unless prior arrangements have been made with the instructor.

Please make every effort to take assignments directly to the instructor. If it is not possible to

do so, take your assignment to SS 1152 and put it in the dropbox. Your assignment will be date-stamped and placed in the instructor's mailbox. It is your responsibility to keep a copy of all assignments in case of loss by any cause. Assignments cannot be returned by staff in the Department office. Assignments will not be accepted over email.

PLAGIARISM

Plagiarism is an extremely serious offence. Please read the following information carefully. The penalty routinely recommended by the English Department for documented plagiarism is failure of the course in which the offence occurred; academic probation is also routinely applied at the Faculty level. Suspension or expulsion can result from severe or repeated plagiarism.

The University Calendar states:

1. Plagiarism - Essentially plagiarism involves submitting or presenting work in a course as if it were the student's own work done expressly for that particular course when, in fact, it is not. Most commonly plagiarism exists when:

- (a) the work submitted or presented was done, in whole or in part, by an individual other than the one submitting or presenting the work (this includes having another impersonate the student or otherwise substituting the work of another for one's own in an examination or test),
- (b) parts of the work are taken from another source without reference to the original author,
- (c) the whole work (e.g., an essay) is copied from another source, and/or,
- (d) a student submits or presents work in one course which has also been submitted in another course (although it may be completely original with that student) without the knowledge of or prior agreement of the instructor involved.

While it is recognized that scholarly work often involves reference to the ideas, data and conclusions of other scholars, intellectual honesty requires that such references be explicitly and clearly noted.

Plagiarism occurs when direct quotations are taken from a source without specific acknowledgement, or when original ideas or data from the source are not acknowledged. Citing your sources in a bibliography is not enough, because a bibliography does not establish which parts of a student's work are taken from other sources. MLA (Modern Language Association) documentation or other recognized forms of citation must be used for this purpose. Advice on adequate documentation can be found at the following web sites:
