### Course description:

Today, science and literature are often thought of as entirely separate academic realms with separate respective practices. In this introductory-level course, however, students will gain an understanding for the ties and relationships between literature and science over the course of history, beginning from the Medieval period and ending in the contemporary era. The course will ask students to consider how these relationships change over time and across cultures, and demonstrate how critical reading and literary analysis can deepen our understanding of said relationships. Being that this is an English course, the majority of the texts will be from literary writers – however, it will also include selections of what today are traditionally understood as distinctly scientific writers and texts. Among other things, students will specifically examine: scientific practice as it is represented in literature, the influence of literature on scientific writing, discovery, and observation, and the origins of science and literature as distinct concepts.

### Required Texts:

1. *The Last Man* by Mary Shelley (Broadview Press, ed. Anne McWhir), published in 1996.

All other readings will be available on the course D2L.

### Assignments and Evaluation:

1. Quizzes: 10%  
Quizzes will be weekly and will test the students' knowledge of the readings for that week.
2. In-class Exercises: 10%  
In addition to quizzes, once a week (on Monday or Wednesday) students will be required to engage in a written exercise related to the readings for that week. Besides testing students' knowledge of the information within weekly readings, it is important that they also engage in dialogue about various interpretations of the texts. Dialogue anticipates questions and misunderstandings, opens up individual perspective, and gives the student a chance to express themselves to form a social identity in the class.

3. First Writing Assignment: 15%  
Essay of 750 words on a subject relevant to the course topics and readings. There will be 2 in-class workshops on both research and essay writing strategy and techniques to help better prepare students for the two writing assignments.
4. Second Writing Assignment: 20%  
Essay of 1,250 words on a subject relevant to the course topics and readings.
5. Midterm Exam (In-class): 20% - The midterm exam will be comprised of several short answer questions, multiple choice, and passage analysis questions (choice of 1-3 questions).
6. Final Exam (Registrar Scheduled): 25% - The final exam format will be of the same format as the midterm. It will *not* be cumulative, but rather based on the readings from the latter half of the term. The exam will be closed-book, but students will be allowed to bring a single index card with notes into the exam. **The exam period for Fall is December 9 – December 19, 2019** and students must be available for examinations up to the last day of the examination period. ### Assignment Submission and Late Assignment Policy

On the date that each writing assignment is due, it should be handed in at the beginning of class. Assignments which are handed in later in the class period will be considered one day late. If a student finds themselves unable to complete an assignment on time (e.g. illness or injury, personal issue, etc.), they should contact the instructor as early as possible before the due date to alert them, and decide if any arrangements can/should be made.

Assignments will be penalized at one-third a letter grade per day of lateness (for instance, a paper that would normally receive a grade of B would receive a B- after one day of lateness). Late assignments can be dropped off face-to-face during office hours, at the instructor's physical mailbox at the Department of English office, 11<sup>th</sup> floor, Social Sciences building, or in the Dept. of English drop box after the office closes (please note that the Social Sciences building closes at 10 PM). **Electronic submissions of course assignments will not be accepted, barring extreme circumstances and if the instructor is contacted beforehand.** As a word of advice: if you are anticipating a possible circumstance like this, please reach out ahead of time, even if you are not certain. In this case, the worst that will happen is that you end up handing it in normally. Technological issues which may impede coursework, such as accessing or using D2L, should be brought to the attention of the instructor as soon as possible, so that they can be resolved quickly and the student can remain on track with their assignments, or being able to access information related to the class.

It is your responsibility to keep a copy of all assignments in case of loss by any cause. Assignments cannot be returned by staff in the Department office.

In class exercises are to be composed in writing during class and handed at the end of the class. Exercises will be graded according to a rubric provided to the students on D2L, which clarifies the criteria for these type of assignments.

While not all assignments need to be completed to pass the course, it goes without saying that a student's grade will suffer significantly more from a grade of a zero than if the student had, at the least, attempted the assignment. It is in each student's best interest, then, to complete all assignments. There will be no extra-credit assignments in this class.

### Course and Assignment Schedule:

This will be posted electronically on the class D2L site ahead of the first class. Students must review the schedule carefully and **make sure that readings are completed ahead of class** where the material will be discussed.

### Policy on Electronic Devices:

Phones are not allowed to be out during the class. This means that they must be turned on “silent” (not “vibrate”) or turned off entirely and stored away – *i.e.* **not on your desk**. If you must use your phone in the case of an emergency, you need to exit the classroom and do so outside (this includes the use of text messaging or other messaging tools/apps).

Laptops, tablets, and other similar devices will be allowed in the classroom. However, their use will be restricted to class related activities – *i.e.* taking notes during lectures and doing any relevant research during group activities. If a student is found to be using their phone or other device, during class, for purposes that are non-class related, they will be restricted from using that device (or any other) for the remainder of the course.

### **PLAGIARISM**

Plagiarism is an extremely serious offence. Please read the following information carefully. The penalty routinely recommended by the English Department for documented plagiarism is failure of the course in which the offence occurred; academic probation is also routinely applied at the Faculty level. Suspension or expulsion can result from severe or repeated plagiarism.

The University Calendar states:

1. Plagiarism - Essentially plagiarism involves submitting or presenting work in a course as if it were the student's own work done expressly for that particular course when, in fact, it is not. Most commonly plagiarism exists when:
  - a) the work submitted or presented was done, in whole or in part, by an individual other than the one submitting or presenting the work (this includes having another impersonate the student or otherwise substituting the work of another for one's own in an examination or test),
  - b) parts of the work are taken from another source without reference to the original author,
  - c) the whole work (e.g., an essay) is copied from another source, and/or,
  - d) a student submits or presents work in one course which has also been submitted in another course (although it may be completely original with that student) without the knowledge of or prior agreement of the instructor involved.

While it is recognized that scholarly work often involves reference to the ideas, data and conclusions of other scholars, intellectual honesty requires that such references be explicitly and clearly noted.

Plagiarism occurs when direct quotations are taken from a source without specific acknowledgement, or when original ideas or data from the source are not acknowledged. Citing your sources in a bibliography is not enough, because a bibliography does not establish which parts of a student's work are taken from other sources. MLA (Modern Language Association) documentation or other recognized forms of citation must be used for this purpose. Advice on adequate documentation can be found at the following web sites:
