## **Course Description:**

An examination of the relationship of literature to the world around us, with instruction in close reading and critical writing. Considers how literature as a cultural practice responds to and reflects its social context. Includes the study of at least one text by an Indigenous author.

### **Course Delivery:**

This course will take place **online** via Desire2Learn (D2L) and Zoom. To best succeed in the course, students are encouraged to participate in the asynchronous learning tasks using the D2L learning environment and synchronous Zoom sessions.

When unable to participate live due to the time difference or unforeseen circumstances, it is **each student's responsibility** to:

- a) catch up on any missed material by asking colleagues to share notes,
- b) review the class outline set out by the instructor prior to each class, and
- c) keep up with the readings as outlined in the Course Schedule.

The Instructor will not provide notes for missed lectures and lectures are not recorded.

The course lasts 7 weeks with the first day of classes on Wednesday, May 5<sup>th</sup> and the last day of classes on Wednesday, June 16<sup>th</sup>.

There will be **12 synchronous Zoom sessions throughout the term** with a one-hour lecture at the start of each session (May 5, 10, 12, 17, 19, 26, 31, June 2, 7, 9, 14 and 16). Students will be given work to do in the asynchronous part of the session, and are expected to undertake it independently.

There are **no make-ups for any of the assignments of this course,** therefore make note of all the due dates and the class times to ensure that you are complying with the deadlines.

Students must complete the following assignments to be eligible to receive a passing grade for the course: The Final Essay, the Final Exam, the Close Reading of a text and the Critical Reading of a Performance of the Text. These four assignments are worth 90% of a student's final grade.

### **COURSE LEARNING OUTCOMES**

Upon successful completion of this course, students will be able to:

- 1. Develop close reading skills understanding how a text is constructed by familiarizing themselves with its various literary components.
- 2. Develop and effectively apply a vocabulary of technical terms and critical tools to interpret texts.
- 3. Write strong, well-supported, clear, and engaging academic essays. Students will understand how to craft arguments and how to support these standpoints effectively through proper documentation, which will include recognizing and avoiding plagiarism.
- 4. Develop library research skills such as searching reference works, books and articles in various formats, and understand how to link these sources to their academic work.
- 5. Read and critique the work of academic scholars by referring to their own research and understanding of class lectures.

#### **LEARNING TECHNOLOGIES AND REQUIREMENTS**

In order to successfully engage in their learning experiences at the University of Calgary, students taking online, remote and blended courses are required to have reliable access to the following technology:

## **Assignments and Evaluation:**

### **Critical Reading of a Performance of a Text (25%)**

Students will be asked to watch an online performance of *Frankenstein* (available through the University of Calgary's library) and compare and contrast specific scenes with the original text which will be analyzed in class lectures. Students will have to engage with issues of how the text is constructed and then adapted for stage (800 words).

## Close-reading Assignment (10%)

Students will be given an excerpt of a text read in class and asked to provide a close-reading based on the themes and ideas given in the lectures (400 words).

## Essay (30%)

Students will be asked to write a clear, argumentative research essay applying the library research skills they have learned and using two refereed sources to support their standpoint (1000 words).

#### Final Exam (25%)

Students will write a Registrar-scheduled exam consisting of short and long answer questions. No multiple-choice questions will be given.

### Participation (10%)

There are two components to this grade:

- 1. Students will answer a set of questions quizzing them on their library research for the writing of their final essay (5% of the Participation grade).
- 2. Students will post comments to 5 discussion questions set by the instructor following some lectures (each question is worth 1% for a possible total of 5% of the Participation grade).
  - There will be a set time to respond to these questions and then the forum will be locked.
  - Students are expected to write 2-3 sentences in a thoughtful manner showing their familiarity with the work.
  - To account for a day when student may have to be absent, students will have 6
    opportunities to submit their posts with only 5 of these posts counting towards their
    participation grade.

## ATTENDANCE AND PARTICIPATION EXPECTATIONS

Students are expected to attend class regularly and to be fully present and engaged in class activities and discussion in a respectful manner that contributes to everyone's understanding and engagement with the course material.

If students miss a synchronous session, it is their responsibility to reach out to colleagues – not the Instructor – for missed class notes, to review the readings assigned by referring to the Course Schedule, and to ensure they are up to date on any instructions given regarding class assignments. There is no

recording of class lectures, therefore students are encouraged to attend the synchronous sessions listed above.

## **Additional Regulations:**

- There is a Registrar Scheduled Final Exam for this course and students must be available to take it during the examination period (June 21-23, 2021).
- There are no make-up assignments for this course. If students miss submitting an assignment, they will receive a grade of "0" on that assignment.
- Students must submit all assignments in the appropriate D2L dropbox in Word or PDF format by 11:30 p.m. on the due dates listed in the Course Schedule. No assignments will be accepted via email or any other means.
- Assignments submitted after the deadline will be penalized with the loss of a third of a grade (an
  A- to B+) for each business day [not class] that the assignment is overdue. No assignments will be
  accepted one week past the assignment deadline without the prior consent of the instructor.
- No extensions will be given on Assignments after the due date. If there are extenuating circumstances, students must request an extension before the assignment due date, and a short extension may be given at the instructor's discretion.
- If you have any questions throughout the course, communicate via email in a respectful, professional and timely manner. I will endeavor to respond to your emails within 24 hours, unless the inquiry has been sent on a weekend, holiday, or an evening. Use only your @ucalgary email for any communication.

- There is no D- grade.
- I will be rounding up the final grade only. For example, if at the end of the course, you receive a 76.5 which would be a B, it will be rounded up to 77, so that your final grade will be a B+.
- Although the A+ is solely an honorific that entails no additional points in the four-point system, the course instructor will employ this mark to distinguish superlative work that exceeds expectations in style, correctness, intellectual depth and breadth, sophistication, and originality.

### **PLAGIARISM**

Plagiarism is an extremely serious offence. Please read the following information carefully. The penalty routinely recommended by the English Department for documented plagiarism is failure of the course in which the offence occurred; academic probation is also routinely applied at the Faculty level. ## The University Calendar states:

- 1. Plagiarism Essentially plagiarism involves submitting or presenting work in a course as if it were the student's own work done expressly for that particular course when, in fact, it is not. Most commonly plagiarism exists when:
  - the work submitted or presented was done, in whole or in part, by an individual other than the one submitting or presenting the work (this includes having another impersonate the student or otherwise substituting the work of another for one's own in an examination or test),
  - b) parts of the work are taken from another source without reference to the original author,
  - c) the whole work (e.g., an essay) is copied from another source, and/or,
  - d) a student submits or presents work in one course which has also been submitted in another course (although it may be completely original with that student) without the knowledge of or prior agreement of the instructor involved.

While it is recognized that scholarly work often involves reference to the ideas, data and conclusions of other scholars, intellectual honesty requires that such references be explicitly and clearly noted.

Plagiarism occurs when direct quotations are taken from a source without specific acknowledgement, or when original ideas or data from the source are not acknowledged. Citing your sources in a bibliography is not enough, because a bibliography does not establish which parts of a student's work are taken from other sources. MLA (Modern Language Association) documentation or other recognized forms of citation must be used for this purpose. Advice on adequate documentation can be found at the following web sites:

Students who are absent from class assessments (tests, participation activities, or other assignments) should inform their instructors as soon as possible.
