Course Description:

In a sense, all literature is connected to the body; literary bodies are idealized, traumatized, and politicized, and they can be profoundly revealing of the cultures into which they are written and read. This course considers works of literature –fiction, poetry, and drama – that represent bodies, particularly marginalized bodies, in ways that complicate, critique, or ‘write back’ to prevailing social and cultural ideologies. In this course, students will read the assigned works carefully and critically with the goal of developing their critical reading and analytical writing skills. The development of research and writing skills will be a central component of the course, and students will receive instruction in the process of composition throughout the term. Course texts will cover a wide range of historical periods and genres and will include texts by indigenous authors.

Course Delivery:

This course will take place online via Desire2Learn (D2L) and Zoom. To best succeed in the course, students are encouraged to participate in all synchronous Zoom sessions and complete all asynchronous learning tasks using the D2L learning environment.

There will be approximately 15 synchronous Zoom sessions throughout the term; Mondays from 3:30-4:45 and Wednesdays from 3:30-4:45. There will be instances when alternative (asynchronous) materials are provided in lieu of a synchronous class session. These will be indicated on the syllabus and I will post reminders in the ‘news’ function in D2L when this will be the case. Synchronous Zoom classes will not be recorded, and it is the student’s responsibility to attend and participate in these sessions.

When unable to participate live due to time difference or unforeseen circumstances, inform the instructor in advance and propose and implement an alternative participation activity (e.g.

submit a brief reflection on the day's assigned reading; collate and submit course notes from classmates; and / or actively contribute to the follow-up online discussion).

Teaching Assistants: When applicable, any TAs assigned for ENGL 251 will assist in the grading of formal writing assignments, including essays and discussion board assignments; monitor email communication; and assist with synchronous tutorials. Their contact details and office hours will be provided when classes begin.

COURSE LEARNING OUTCOMES

Upon successful completion of the course, students will be able to:

1. Close read literature in a variety of forms and genres. This process begins by understanding that a text is constructed, and not a transparent reflection of reality.
2. Employ a range of technical terms and critical tools with which to interpret texts.
3. Write strong, well-supported, clearly written academic essays with effective and persuasive analytical arguments.
4. Understand what constitutes plagiarism and use proper documentation in their written work.
5. Develop library research skills: how to search and locate reference works, books and articles, both electronic and print; and how to use print and online resources responsibly and thoughtfully.
6. Engage with other scholars by responding to critical texts.

Assignment Details:

Reading Quizzes x 4: (15%)

- Quizzes will have multiple choice or fill-in-the-blank style questions covering assigned reading(s). Quizzes will be open (in D2L) until midnight of the day on which they are announced. The quiz announcement and password will be given during synchronous ZOOM classes without prior warning.
- **Students may miss one reading quiz during the semester without penalty. Therefore, there will be no opportunity to make up or be excused from any reading quiz for any reason.**

Discussion Board Assignments 25%: (3 posts @ minimum 350 words)

- Students will be assigned 3 discussion posts over the course of the term.
- Students will write a formal discussion post in response to a question or prompt provided, and they will respond to a classmate's post.
- Initial posts will be worth 65% of the overall score; responses to classmates will be worth 35% of the overall score.
- Students MUST complete the discussion post and response during the specified timeframe. Discussion forums will lock at 11:30pm on the due date and there will be NO

opportunity to make up these posts. For this reason, students are encouraged to post well in advance of the deadline to avoid last-minute technology issues.

Thesis Statement and Annotated Bibliography (Approx. 500 words): (15%)

Students will submit a tentative thesis statement and an annotated bibliography of sources in development of their research essay.

Research Essay (1500 words): (25%)

Students will choose to write on ONE of a selection of essay questions or will develop their own topic in consultation with the instructor. Students will write a final research paper using scholarly secondary sources to supplement their argument regarding the primary text(s).

Registrar-scheduled Final Exam: (20%)

- The exam will be open book and will be scheduled by the registrar's office.
- It will be written in D2L during a specified period of time.
- The exam will require short and/or long written answers.
- The exam will be cumulative (cover all material from the beginning of the semester).

ATTENDANCE AND PARTICIPATION EXPECTATIONS

Students are expected to attend class regularly and to be fully present and engaged in class activities and discussions. If students miss a class session, they should review all posted materials (PPT slides, assigned readings, etc.) and connect with a classmate in order to get notes for the missed class.

Additional Regulations:

- This course will have a Registrar scheduled final exam, and the exam will be open book, written in D2L.
- Students must be available for examinations up to the last day of the examination period April 19, 2021 – April 29, 2021.

PLAGIARISM

The University Calendar states:

1. Plagiarism - Essentially plagiarism involves submitting or presenting work in a course as if it were the student's own work done expressly for that particular course when, in fact, it is not. Most commonly plagiarism exists when:
 - a) the work submitted or presented was done, in whole or in part, by an individual other than the one submitting or presenting the work (this includes having another impersonate the student or otherwise substituting the work of another for one's own in an examination or test),

- b) parts of the work are taken from another source without reference to the original author,
- c) the whole work (e.g., an essay) is copied from another source, and/or,
- d) a student submits or presents work in one course which has also been submitted in another course (although it may be completely original with that student) without the knowledge of or prior agreement of the instructor involved.

While it is recognized that scholarly work often involves reference to the ideas, data and conclusions of other scholars, intellectual honesty requires that such references be explicitly and clearly noted.

Plagiarism occurs when direct quotations are taken from a source without specific acknowledgement, or when original ideas or data from the source are not acknowledged. Citing your sources in a bibliography is not enough, because a bibliography does not establish which parts of a student's work are taken from other sources. MLA (Modern Language Association) documentation or other recognized forms of citation must be used for this purpose. Advice on adequate documentation can be found at the following web sites:
