Course description: No prerequisites. This course will introduce students to the study of literature as a field of cultural production. Focusing on current debates in the literary field, the course will examine claims that the study of literature is a fundamentally reactionary undertaking that contributes to social inequities.

Texts and readings:

Hari Kunzru. *White Tears* (Vintage, 2017).

Jesmyn Ward. *Sing, Unburied, Sing* (Scribner, 2017)

Both of the above are required for this course and are available in the bookstore.

Assignments and Evaluation:

This class will use a version of scaffolded learning for its evaluation. The advantage of this approach is that it places responsibility for workload directly in the hands of the students. There are a total of forty-nine different assignments for this course, twenty of which will be completed during class time and twenty-nine of them outside of class time. Students are not required to do all of the assignments, but the final grade in the course will reflect the effort contributed by each student. Assignments will be graded as Proficient, Below Proficient, and Above Proficient. A grade of Proficient will result in full marks being assigned for the work. Works adjudicated as Below Proficient will lose up to half their marks, while those graded as Above Proficient may receive greater than 100%. A breakdown of the various assignments and their weights is below:

Writing Response (10 x 30 points each = 300 possible points). At ten points during the term, students will be prompted to write a brief response to a question posed by the instructor that directly relates to the Required Readings for a class session. Students should respond in approximately a paragraph to the prompt. Students are required to post their response to the dropbox on D2L no later than midnight on the day *before* the class session in which it is due. As these prompts will be discussed in class time, a printed copy should also be brought to the class on the appropriate day.

Thesis Statements (10 x 20 points each = 200 possible points). At ten points during the term, students will be prompted to write a thesis statement that responds to a question posed by the instructor that directly relates to the required novels for this course. Students should respond in a single sentence of no more than FIFTY words. Students are required to post their response to the dropbox on D2L no later than midnight on the day *before* the class session in which it is due. As these prompts will be discussed in class time, a printed copy should also be brought to the class on the appropriate day.

In-Class Writing (20 x 20 points each = 400 possible points). During twenty of our class sessions, students will be afforded time to do brief responses to the work of their peers. Responses should be evaluative and constructive, offering substantive suggestions for improving the work submitted by your peers. In-Class writing will be collected during class sessions.

Essay Summary (3 x 50 points each = 150 possible points). On three dates (2 October, 9 October, and 16 October) students will be responsible for submitting a summary of the arguments advanced in the required reading for the day. Summaries should analyze the logic of the claims made and the appropriateness of the evidence marshalled, including an assessment of the strength of the argument and indications of how it might be improved. Students should respond in a single sentence of no more than FIFTY words. Students are required to post their response to the dropbox on D2L no later than midnight on the day *before* the class session in which it is due. As these summaries will be discussed in class time, a printed copy should also be brought to the class on the appropriate day.

Short Assignment #1 (1 x 100 = 100 possible points). Canadian Lit Prizes. Establish the odds on the Giller Prize or the Governor General's Prize (or both) with a detailed rationale. Who is likely to win these prizes and for what reasons? Bonus points might be awarded for getting this one right, but it is not necessary to be correct to gain full marks. Due: October 17. Students are required to post their response to the dropbox on D2L no later than midnight on the day *before* the class session in which it is due. As these assignments will be discussed in class time, a printed copy should also be brought to the class on the appropriate day.

Short Assignment #2 (1 x 100 = 100 possible points). Mark Lombardi Graphic. Create a Mark Lombardi relationship graphic to illustrate the inter-connectedness of book blurbs. Pick a book (any book!) and read the blurbs on the back. Blurbs should be from other writers rather than institutions (Stephen King, say, rather than the *New York Times*). Find a book by that blurber and read those blurbs. Chart the connections in map form. A Proficient project will include at least a dozen links and a short reflection on the significance of the findings. Due: October 29. Students are required to post their response to the dropbox on D2L no later than midnight on the day *before* the class session in which it is due. As these assignments will be discussed in class time, a printed copy should also be brought to the class on the appropriate day.

Short Assignment #3 (1 x 100 = 100 possible points). University Admission. Play College Scholarship Tycoon as many times as you need to with different strategies to win and/or lose the game. Write a short essay reflecting on what you learned from playing the game, and how you feel that university admissions should operate in real life. Due: December 3. Students are required to post their response to the dropbox on D2L no later than midnight on the day *before* the class session in which it is due. As these assignments will be discussed in class time, a printed copy should also be brought to the class on the appropriate day.

Essay #1 (1 x 500 = 500 possible points). An essay on Hari Kunzru's *White Tears*. This paper should be six to eight pages in length. This paper should build upon one of the five thesis statements submitted during the term. Papers will be graded on scholarly research, analysis, and argumentation. Students are required to post their response to the dropbox on D2L no later than midnight on 23 October.

Essay #2 (1 x 500 = 500 possible points). An essay on Jesmyn Ward's *Sing, Unburied, Sing*. This paper should be six to eight pages in length. This paper should build upon one of the five thesis statements submitted during the term. Papers will be graded on scholarly research, analysis, and argumentation. Students are required to post their response to the dropbox on D2L no later than midnight on 6 December.

Essay #3 (1 x 150 = 150 possible points). Students are encouraged to follow a Canadian writer or writers on Twitter during the term, or the hashtag #canlit. At various points during the term, it is likely that debates relevant to the course will transpire on Twitter. Students may write a brief (2-3 page) essay on the debates and the way that it is being staged. This should not be a simple 'he said, she said' report, but she evaluate the relevant claims and examine the underlying assumptions that shape them. Papers may be submitted at any time during the term, but must be submitted before the end of term. Papers will be graded on scholarly research, analysis, and argumentation. Students are required to post their response to the dropbox on D2L no later than midnight on 6 December.

Registrar-scheduled final exam. There will not be a registrar-scheduled final exam in this course.

Please make every effort to take assignments directly to the instructor. If it is not possible to do so, take your assignment to SS 1152 and put it in the dropbox. Your assignment will be date-stamped and placed in the instructor's mailbox. It is your responsibility to keep a copy of all assignments in case of loss by any cause. Assignments cannot be returned by staff in the Department office.

PLAGIARISM

Plagiarism is an extremely serious offence. Please read the following information carefully. The penalty routinely recommended by the English Department for documented plagiarism is failure of the course in which the offence occurred; academic probation is also routinely applied at the Faculty level. Suspension or expulsion can result from severe or repeated plagiarism.

The University Calendar states:

1. Plagiarism - Essentially plagiarism involves submitting or presenting work in a course as if it were the student's own work done expressly for that particular course when, in fact, it is not. Most commonly plagiarism exists when:
 - (a) the work submitted or presented was done, in whole or in part, by an individual other than the one submitting or presenting the work (this includes having another impersonate the student or otherwise substituting the work of another for one's own in an examination or test),
 - (b) parts of the work are taken from another source without reference to the original author,
 - (c) the whole work (e.g., an essay) is copied from another source, and/or,
 - (d) a student submits or presents work in one course which has also been submitted in another course (although it may be completely original with that student) without the knowledge of or prior agreement of the instructor involved.

While it is recognized that scholarly work often involves reference to the ideas, data and conclusions of other scholars, intellectual honesty requires that such references be explicitly and clearly noted.

Plagiarism occurs when direct quotations are taken from a source without specific acknowledgement, or when original ideas or data from the source are not acknowledged. Citing your sources in a bibliography is not enough, because a bibliography does not establish which parts of a student's work are taken from other sources. MLA (Modern Language Association) documentation or other recognized forms of citation must be used for this purpose. Advice on adequate documentation can be found at the following web sites:
