**Course Description:**

This class is a critical and historical study of children's and young adult literature. A primary goal of this class is to consider the strangeness of children's literature: not only is it rare among genres for being named after the audience it aims to address, but children's literature is also unique in the way it generates so much anxiety among critics and readers with strong investments in how we define the genre and what, exactly, its texts should contain. Furthermore, children's literature fascinates in its inspiration of countless adaptations, retellings, and appropriations, many of which challenge popular notions of childhood innocence and development. Students will consider the terms through which critics have sought to define (or not define) children's literature, the expectations that surround the genre, and how children's literature and its adaptations may subvert and/or bolster these expectations. Students will depart the class having cultivated critical tools for approaching a range of texts for young people, in addition to developing a heightened awareness of the fraught relationship between children's and young adult literature and its adult authors, critics and audiences. This class has no prerequisites, and is not open to students with credit in English 398.

## Assignments and Evaluation:

### **Term Project** (25%, graded by TAs)

Select one of the following two options. For this assignment, you may work independently or in groups (max. 3 people). If you choose to work as a group, you accept that every group member will receive the same grade. Detailed instructions for this assignment will be distributed separately.

#### *Option 1: Course Design*

You will design an imaginary children's literature-related course based on the topic and audience of your choice (e.g. the history of young adult literature; Indigenous children's literature; LGBTQ children's literature; banned/censored picture books; fairy tale adaptations; children's literature for primary school teachers; children's literature for economics majors; etc...). This assignment will consist of three parts: a max. 750-word critical overview of your course and the themes and questions it will explore (including a major term assignment idea), an annotated bibliography that summarizes and explains the relevance of your selected texts, and your proposed reading schedule (based on a 13-week term). It is recommended that you meet with your course TA in advance to discuss your ideas.

#### *Option 2: Creative Project*

You will produce a creative term project using the medium of your choice—short film, picture book, graphic narrative, novel chapter, web-based video game, etc.—that critically engages with our course texts and themes (e.g. fairy tale retelling; *Peter Pan* adaptation; writing from historically marginalized perspectives for young people). Although the creative component can take any shape, you must also submit a max. 750-word critical overview that explains how our course readings and discussions have influenced your approach to and design of this project. If you select this option, it is strongly recommended that you meet with your course TA in advance to discuss your ideas.

### **In-Class Assignments** (15%)

Over the course of the term, the instructor will assign a minimum of **four** in-class activities that may include short oral presentations, reading quizzes administered via TopHat, creative projects, and writing exercises, among others. These assignments will deepen your engagement with course material and encourage regular attendance and participation at lectures. Your highest **three** assignment scores will each contribute 5% towards your final grade; the lowest grade(s) will be dropped. There will be no advance warning about graded in-class activities and no opportunities for make-up assignments.

### **Participation Cards** (10%, graded by instructor & TAs)

On **five** occasions throughout the term (see reading schedule for deadlines), you will submit a 3x5" index card (no paper cut-outs or substitutes permitted!) to the instructor. These cards are an opportunity to share your critical thoughts related to course material and/or things you read/saw/heard that made you think about our class. You should not simply raise a question, but rather draw connections between thoughts/texts and/or engage critically with your own reactions to course materials. **You must submit these cards in-person, in class** (i.e. you cannot have someone submit the card on your behalf). Each card will receive a grade out of 2 and count for 2% toward your final mark. **No exceptions will be permitted**; if your card isn't submitted on-time in-class, you won't receive the grade!

### **Mid-Term Test** (15%)

### **Final Exam** (35%)

The final exam will be registrar scheduled. Exams will be held between Dec. 10-20, 2018. Students must be available for examinations up to the last day of the examination period.

### Assignment Policies:

- Assignments submitted after the deadline will be penalized with the loss of 3% for each day that the assignment is overdue. No assignments will be accepted one week past the assignment deadline without the prior consent of the instructor. Participation cards will not be accepted beyond their original due date. Otherwise, extensions are only granted under exceptional circumstances.
- There will be no assignments given for extra credit.
- Students must complete the term project and final exam in order to qualify for a passing grade in this course.

**My policy: I round grades upwards if they are within 0.50% of a higher grade. Please do not contact me to request an adjustment to your final grade unless (1) you suspect I have made an error, or (2) you are planning to formally appeal your results.**

Although the A+ is solely an honorific that entails no additional points in the 4-point system, the course instructor will employ this mark to distinguish superlative work that exceeds expectations in style, correctness, intellectual depth and breadth, sophistication, and originality.

**Lecture notes, slide presentations, and summaries of class discussion will not be distributed in this class, nor will they be made available to students who miss classes.** Students are responsible for maintaining their own notes throughout the course, and are strongly encouraged to develop strategies during this course for effective note-taking, a skill that is invaluable for post-secondary studies in any discipline. (n.b. It is not useful to transcribe every word of a lecture—or, for that matter, to preserve it with a recording device: the best strategies include attentive listening, the brief noting of important terms and concepts during lecture or discussion, and a concise and articulate summary written at the end of class). In addition to keeping clear and comprehensive notes, students are advised to keep up with course readings, to complete all assigned readings by the stipulated date, and to submit all work in a timely fashion, following all instructions for each assignment.

Using any source whatsoever without clearly documenting it is a serious academic offense. Consequences include failure on the assignment, failure in the course and possible suspension or expulsion from the university. **PLAGIARISM**

Plagiarism is an extremely serious offence. Please read the following information carefully. The penalty routinely recommended by the English Department for documented plagiarism is failure of the course in which the offence occurred; academic probation is also routinely applied at the Faculty level. Suspension or expulsion can result from severe or repeated plagiarism.

The University Calendar states:

1. Plagiarism - Essentially plagiarism involves submitting or presenting work in a course as if it were the student's own work done expressly for that particular course when, in fact, it is not. Most commonly plagiarism exists when:

- (a) the work submitted or presented was done, in whole or in part, by an individual other than the one submitting or presenting the work (this includes having another impersonate the student or otherwise substituting the work of another for one's own in an examination or test),
- (b) parts of the work are taken from another source without reference to the original author,
- (c) the whole work (e.g., an essay) is copied from another source, and/or,
- (d) a student submits or presents work in one course which has also been submitted in another course (although it may be completely original with that student) without the knowledge of or prior agreement of the instructor involved.

While it is recognized that scholarly work often involves reference to the ideas, data and conclusions of other scholars, intellectual honesty requires that such references be explicitly and clearly noted.

Plagiarism occurs when direct quotations are taken from a source without specific acknowledgement, or when original ideas or data from the source are not acknowledged. Citing your sources in a bibliography is not enough, because a bibliography does not establish which parts of a student's work are taken from other

sources. MLA (Modern Language Association) documentation or other recognized forms of citation must be used for this purpose. Advice on adequate documentation can be found at the following web sites:
