Course description: Reading and analysis of Old English poetry in the original language.

Prerequisite: English 401*

*The prerequisite has been waived for this iteration of the course.

Liuzza, Roy, trans. Beowulf. 2nd ed. Broadview.

Liuzza, Roy, ed. and trans. *Old English Poetry: An Anthology*. Broadview.

McGillivray, Murray. Old English Reader. Broadview.

McGillivray, Murray. A Gentle Introduction to Old English. Broadview.

(Please note that the *Gentle Introduction* is required only for those students who have not taken the formal prerequisite, English 401.)

Assignments and Evaluation:

There are two assignment structures in English 403, one for students who have taken the formal prerequisite course, English 401, or equivalent and one for students who have not taken English 401 or equivalent.

For students with English 401 or equivalent:

In-class translations 25%

Class discussion 15%

Seminar introduction of a poem	20%
Final essay	40%
For students without English 401 or equivalent:	
In-class translations	15%
Class discussion	15%
Grammar test	10%
Seminar introduction of a poem	20%
Final essay	40%

After an introductory period, each day's class will involve in-class translation of passages of Old English poetry and discussion of poems. Each student will necessarily participate in translation and discussion frequently.

In-class translations are evaluated on their accuracy and the understanding they show of the original Old English text.

Contributions to class discussion are not evaluated on their frequency as much as on their clarity, relevance, perceptiveness, intellectual daring, and thoughtfulness.

A student may ask the instructor for an approximate translation or discussion grade at any point in the course.

Students who have not taken English 401 or equivalent will be tested on their knowledge of the inflectional system of Old English in a grammar test at about the mid-point of the course.

Students will introduce one poem to the class in a seminar-style presentation of about twenty minutes.

Essay topics will be determined in consultation with the instructor.

There is no final examination in this class.

Assignments submitted after the deadline will be penalized with the loss of a third of a grade (e.g. an Ato B+) for each day (not class) that the assignment is overdue.

Please make every effort to take assignments directly to the instructor. If it is not possible to do so, take your assignment to SS 1152 and put it in the dropbox. Your assignment will be date-stamped and placed in the instructor's mailbox. It is your responsibility to keep a copy of all assignments in case of loss by any cause. Assignments cannot be returned by staff in the Department office.

PLAGIARISM

Plagiarism is an extremely serious offence. Please read the following information carefully. The penalty routinely recommended by the English Department for documented plagiarism is failure of the course in which the offence occurred; academic probation is also routinely applied at the Faculty level. Suspension or expulsion can result from severe or repeated plagiarism.

The University Calendar states:

- 1. Plagiarism Essentially plagiarism involves submitting or presenting work in a course as if it were the student's own work done expressly for that particular course when, in fact, it is not. Most commonly plagiarism exists when:
- (a) the work submitted or presented was done, in whole or in part, by an individual other than the one submitting or presenting the work (this includes having another impersonate the student or otherwise substituting the work of another for one's own in an examination or test),
- (b) parts of the work are taken from another source without reference to the original author,
- (c) the whole work (e.g., an essay) is copied from another source, and/or,
- (d) a student submits or presents work in one course which has also been submitted in another course (although it may be completely original with that student) without the knowledge of or prior agreement of the instructor involved.

While it is recognized that scholarly work often involves reference to the ideas, data and conclusions of other scholars, intellectual honesty requires that such references be explicitly and clearly noted.

Plagiarism occurs when direct quotations are taken from a source without specific acknowledgement, or when original ideas or data from the source are not acknowledged. Citing your sources in a bibliography is not enough, because a bibliography does not establish which parts of a student's work are taken from other sources. MLA (Modern Language Association) documentation or other recognized forms of citation must be used for this purpose. Advice on adequate documentation can be found at the following web sites:
