Description & Goals

"Books are not absolutely dead things, but do contain a potency of life in them to be as active as that soul was whose progeny they are; nay, they do preserve as in a vial the purest efficacy and extraction of that living intellect that bred them. (...) Many a man lives a burden to the earth; but a good book is the precious life-blood of a master spirit, embalmed and treasured up on purpose to a life beyond life."

To borrow John Milton's words from a 1644 pamphlet against censorship, in this course we will disinter the intellects of master spirits. In plain English, that means we'll read poetry from the 17th century to discover how its people thought and read, lived and died, loved and mourned. Their words are a conduit from past imaginations to our own — informing how we live our own lives, and think our own thoughts. Writers in this century confronted the political turmoil of a civil war, the discoveries of a scientific revolution, the geographical expansion of English sovereignty, and the spread of ideas in a new public sphere. They wrote in a range of forms and genres, from epics to elegies.

In English 411 we'll read the entirety of John Milton's epic on cosmic and human origins, *Paradise Lost*, alongside selected metaphysical poems of love, belief, mourning, and discovery. By the end of this course you will be able to:

- annotate and close-read texts to gather evidence for your interpretations (Presentations);
- reflect on texts and on my podcast lectures; and on your goals, your learning, and your habits of thought (Journals);

- formulate original and persuasive written arguments about texts (Response Paper and Final Exam); and
- build knowledge collaboratively in oral conversations (Participation).

Formats: D2L, Zoom, & Slack

This course will take place online via Desire2Learn (D2L), Zoom, and Slack. You are also required to listen to weekly audio podcasts, which will be posted to D2L. Our Zoom sessions will also be recorded and posted to D2L; these recordings will be used to support student learning only and will not be shared or used for any other purpose. All dates are in the Schedule below.

To succeed in this course, you should participate in the asynchronous learning on D2L and the synchronous Zoom (video) and Slack (chat) sessions. If you are unable to participate for any reason, inform the instructor in advance to propose and implement an alternative activity (e.g., watching recordings, submitting a brief reflection, and contributing to the Slack discussion).

Zoom links and passwords are only for students registered in this course. To ensure that our Zoom sessions are private, do not share these links or passwords with others on any platform. Zoom recordings and materials presented in Zoom, including any teaching materials, must not be shared, distributed or published without the instructor's permission.

Please be prepared, as best as you are able, to join our synchronous classes in a quiet space where you can be fully present and engaged. You will be advised by your instructor when you are expected to turn on your webcam (e.g. for group work or presentations). Detailed descriptions of each assignment are below. There is no Registrar-scheduled exam in this course.

I use percentages to grade every assignment, and use D2L to convert them to these letter-grade equivalents:

Only at the end of the course do I convert your final percentage grades into letters or GPA scores. Note that, according to the University Calendar, instructors may use their discretion when rounding upwards or downwards when the average of term work and exams is between two letter grades.

Policies

Submission & Due Dates

You must complete these 4 assignments to pass this course: all 6 Journals, the Response Paper, the Final Exam, and the Participation Report.

Due dates are always midnight of the day indicated in the Course Schedule. Each student is permitted 1 extension of 1 day without penalty, on either the Response Paper or the Final Exam. You may also submit any 1 Journal up to 12 hours late without penalty.

I penalize late assignments — i.e. those submitted after midnight on the due date — at a rate of 5% daily for the first two days, and 1% daily thereafter. You must submit all assignments no later than one calendar week after the due date. Any later, and you will receive a zero grade on that assignment. Extraordinary cases of medical emergencies and other domestic afflictions may be subject to extensions, but only at my discretion.

If you fail to submit the Final Exam you must inform me as soon as possible. I may request documentary evidence for the reason you give for your absence. For details on possible forms of documentation, including statutory declarations, see here. If I determine that your evidence is acceptable, I may decide that alternate arrangements can take forms other than make-up tests or assignments. For example, the weight of a missed grade may be added to another assignment or test.

E-mail

All course communications must occur through your @ucalgary e-mail, and I will respond to e-mails sent via @ucalgary accounts within 48 hours. Do not follow up before 48 hours have elapsed.

Assignment Descriptions

Journals

These fall into two categories: reflections on your own mind, and responses to our texts, podcasts, and discussions. Each journal will be about 300 words long, a paragraph or two — with the possible exception of Week 1, when you can record a 3-minute video. Write in an informal, approachable register. I mean 'informal' in structure, not grammar: follow the standard rules of sentence structure, spelling, punctuation, and so on, but forget the rules of formal essay-writing. There's no need for an introduction, body, or conclusion here; use whatever structure addresses the question or topic. See my guide to Effective Critical Writing for more detailed advice.

Post your journals to the designated D2L Discussion Board before midnight on each Friday that they're due. (You can only read others' posts after you submit your own.)

Topics

In Week 1, write a self-introduction. Who are you, and why are you here? What are your favourite book(s) and what do you read for pleasure? What knowledge and skills do you intend to gain from this course? If you're taking English 411 because it's a program requirement, tell us why you think a course like this is required. In Week 1 (only) you have the option of recording a 3-minute video, rather than writing 300 words, to address these questions.

From Weeks 2 to 12 you'll post 5 journals in alternating weeks (excepting Week 4): Groups 1-4 in W3, W5, W7, W9, and W11; and Groups 5-8 in W2, W6, W8, W10, and W12. Respond directly to that week's podcast. Tell us how our discussions over video (Zoom) and in chats (Slack) made you think differently about the assigned text(s), and quote the text(s) at least twice. For instance, you could start by saying that the podcast provoked some questions, specifically about certain passages in an assigned text; and then describe how someone's comments over video or chat made you view those problems differently. Or you could compare your methods of reading/annotating that week's text(s) to your experience of other texts.

Evaluation

Journals are graded on a pass/fail system. Earn full marks by submitting all 6 on time, each meeting these explicit criteria. No journal will pass without directly and explicitly referring to that week's podcast episode.

Response Paper

Before midnight on Friday 2 October, submit a 1000-word essay (with an introduction, 2 paragraphs, and a conclusion) quoting any 2 of the 3 essays by Bush, Ricks, and Burnett "On Style and Versification" in Teskey's edition of *Paradise Lost* (476-91). Using at least 5 quotations from *Paradise Lost*, each about 1 line or longer, assess whether you agree or disagree with the arguments of your two chosen critics.

The length of your essay should not exceed 1000 words. For full marks, your essay will make (1) a rigorous and thorough argument in (2) clear, concise, and natural language that (3) obeys the rules of grammar. For details on these criteria, see my guide to Effective Critical Writing.

Presentations

In two different weeks of the course, you will give an audio or video presentation on a brief passage from two different books of *Paradise Lost*, or from both Milton and another poet we read in this course.

At least 48 hours before the class when we are scheduled to discuss either of your chosen books or poets, post a brief passage of about 5-7 lines from the poem to the **#passages** channel in Slack. That is how you claim this passage for yourself; it may not overlap with other students' passages.

Then at least 24 hours before the same class, post a presentation in which you (1) recite your passage; (2) discuss how you annotated it, including the words that you looked up in the Oxford English Dictionary (OED); and (3) ask a question for the class to discuss (i.e. one with a nuanced answer, not a binary answer).

Your presentation should be no longer than 4-5 minutes. If you opt for audio, include at least 1 image of your annotations.

For full marks, your recitation will be clear and vivid; your annotations will cover diction (word choices) and at least 1 other term from my guide to Close Reading; your definitions from the OED will be correct and illuminating; your discussion question will be interesting and provocative; and you will transcribe that question into a Slack thread and contribute to that conversation.

Participation

Your participation grade depends on your engagement with every facet of this course: with our synchronous Zoom/Slack classes; with our asynchronous Podcast classes; and with all of the reading, annotating, writing, reflecting, researching, recording, revising, and other activities related to our texts and assignments. That means you make regular, substantive contributions to class discussions over video (Zoom) and chat (Slack); and you attend classes with an annotated copy of the assigned texts, ready to discuss them. When you have questions about the course material and assignments, you pose them directly to me (in office hours, before or

after class, or in separate appointments) rather than sending me e-mails or direct messages. And you never (seriously, *never*) ask me a question you can answer by reading this course outline.

Participation is a self-reporting exercise. That means on 9 December you submit to the designated D2L Dropbox a 1-page account of how you engaged with the course, our readings, and our assignments. In other words, what evidence can you offer that you were present in both body and spirit during our meetings; that you did more than the bare minimum to read, analyze, annotate, and think about our readings; that you reflected thoughtfully on your individual assignments; that you attended my Zoom office hours? Define what 'engagement' means to you, and cite evidence of yours.

Finally, on the basis on this evidence, award yourself a grade out of 15. Break down your score into components: 10 marks for synchronous activities in our Zoom/Slack classes and 5 for asynchronous activities including our Podcast classes and your preparations for class and work on assignments. If I agree with your self-assessment and evidence, I will give you that grade.

Dos & Don'ts for Participation Reports

- Do be fair to yourself.
- Don't claim to have done more than you really did.
- Do address the terms of the assignment. It asks you for evidence that you did more than the bare minimum, so don't focus too much on how you met basic course requirements by attending class, doing readings, or working on assignments. How did you *exceed* these requirements?
- Don't start at a perfect score and deduct points; start at zero and make a case for each point you earn.
- Do put some effort into your report. The best ones tell an interesting story of your engagement through time. They confess your shortcomings without making excuses for them. They conclude by summarizing why engagement is worthwhile, and what you learned about yourself through your engagement with the course.
- Don't flatter me into giving you a grade higher than you deserve. I always appreciate constructive criticism more than hollow praise.
- Do be credible; tell me not only what you did, but what more you could have done to earn a higher grade. For instance, did you always complete your assigned readings before class? (Be honest.) There is far more credibility in an honest, explicit report than in an overconfident, vague one.
- Do compare your engagement with this class to your engagement with other classes.

Module Quizzes

Two times in this course, you'll watch a short video on my YouTube channel and then complete a quiz in D2L on what you've learned. The videos cover skills that are key to your success in this and other courses.

They decode the skills of reading and quoting texts to write persuasive and grammatically correct literary criticism.

After you watch the videos you should be able successfully to complete the quiz. Both quizzes will include a series of questions not just about the information you learned in the video, but applying your new knowledge to different information. Both quizzes are worth 5%, and should take you less than 40 minutes to finish; both will have a time limit of 60 minutes.

<u>The first video</u> (and quiz) covers ten grammar mistakes to avoid. <u>The second video</u> is on how to read texts like a literary critic, and how to develop arguments about them. I will not test you on an optional <u>third video</u>, on when and how to quote texts to support arguments with evidence.

Final Exam

This exam will be released in D2L on 9 December and be due by midnight on 15 December. You will write 2000 to 3000 words making a comprehensive argument that covers most of the texts we have read, including multiple passages from a range of books of *Paradise Lost*. In the 'Content' section of D2L you can view the 2012 and 2019 versions of this exam; yours will have similar instructions and pose a comparably broad question.

Academic Integrity

While scholarly work often involves reference to the ideas, data and conclusions of other scholars, intellectual honesty requires that such references be explicitly and clearly noted.

Plagiarism occurs when direct quotations are taken from a source without specific acknowledgement, or when original ideas or data from the source are not acknowledged. Citing your sources in a bibliography is not enough, because a bibliography does not establish which parts of a student's work are taken from other sources. MLA (Modern Language Association) documentation or other recognized forms of citation must be used for this purpose.

Using any source whatsoever without clearly documenting it is a serious academic offence. If you submit an assignment that includes material (even a very small amount) that you did not write, but that is presented as your own work, you are guilty of plagiarism. The consequences include failure on the assignment or in the course, and suspension or expulsion from the university. For details, see here.

Please read the following information carefully. The penalty routinely recommended by the English Department for documented plagiarism is failure of the course in which the offence occurred; academic probation is also routinely applied at the Faculty level. Suspension or expulsion can result from severe or repeated plagiarism.

The University Calendar states:

Essentially plagiarism involves submitting or presenting work in a course as if it were the student's own work done expressly for that particular course when, in fact, it is not. Most commonly plagiarism exists when:

- (a) the work submitted or presented was done, in whole or in part, by an individual other than the one submitting or presenting the work (this includes having another impersonate the student or otherwise substituting the work of another for one's own in an examination or test),
- (b) parts of the work are taken from another source without reference to the original author,
- (c) the whole work (e.g., an essay) is copied from another source, and/or,
- (d) a student submits or presents work in one course which has also been submitted in another course (although it may be completely original with that student) without the knowledge of or prior agreement of the instructor involved.

Principles
