Course description:

This course provides a rough survey of the development of what came to be called Canadian literature, in English, from the late 18th century to 1950. We will consider this writing through multiple frames: its situation within the wider Empire; the distinctions between “popular” and “literary”; the relationship of the national to the global; and its role in the larger colonial project, among others. We will read letters, travel narratives, poetry, novels, and short fiction, and through archival research attempt to situate this writing within its historical context.

Students are expected to attend regularly and have the day’s assigned readings completed before class. The participation grade will measure this through occasional, unannounced, elementary quizzes on the day’s assigned reading. There will be five such quizzes; the lowest grade will be dropped and the remaining four averaged to determine your grade for this component of the course. This is to account for unfortunate absences from class, such as those due to illness. Consequently, there will be no rewrites of quizzes.

The archive assignment will involve primary research in the TFDL. There will be multiple options for this assignment, which students will sign up for at the first class. These options will include working with 19th century letters by arctic explorers, late 19th- and early 20th-century books of poetry

and contemporary reviews of the poetry, a cinematic version of *Anne of Green Gables*, an online archive of a little magazine from the 1920s, little magazines from the period of the Second World War, and drafts of poems by Earle Birney. Students will complete these assignments *before* we study the writers in question, and will be expected to share their findings with the class on D2L and be prepared to talk about their work in class. A four-page paper will also be part of each assignment. Further details on these assignments will be given in class.

You will write an eight-page (2000 word) research paper on one of the longer texts we are studying. This paper will be due on the last day of classes. Several classes before the paper is due, you will submit a 250-word abstract detailing the topic and thesis of your paper. The abstract will be worth 5%, and the paper 25%.

There will be a midterm test and a final exam. The final exam will be cumulative, and will be scheduled by the Registrar.

You do not have to complete all assignments to receive a passing grade in this course. Assignments submitted after the deadline will be penalized (e.g. with the loss of a third of a grade for each day [not class] that the assignment is overdue). Extra-credit assignments will not be offered.

*Note: Please make all efforts to take assignments directly to the instructor. If it is not possible to do so, take your assignment to SS1152 and place it in the drop-box. Your assignment will then be date-stamped and placed in your instructor's mailbox. Please keep a copy of your assignment in case of loss by any cause. **Assignments cannot be returned by staff in the Department office.** E-mailed submissions will not be accepted and will be deleted.*

Note regarding technologies:

Please turn off all communication devices during class. Laptop computers are acceptable in class as long as they do not present a distraction to others. I reserve the right to ban computers from the class if anyone's computer presents a distraction. Much of this class will involve close readings from literary texts. As such, students are required to have the texts to be discussed with them in class, including hard copies of materials posted to D2L. Students who consistently do not have the texts with them in class will receive a grade of '0' for participation, after a written warning from the instructor.

PLAGIARISM

Plagiarism is an extremely serious offence. Please read the following information carefully. The penalty routinely recommended by the English Department for documented plagiarism is failure of the course in which the offence occurred; academic probation is also routinely applied at the Faculty level. Suspension or expulsion can result from severe or repeated plagiarism.

The University Calendar states:

1. Plagiarism - Essentially plagiarism involves submitting or presenting work in a course as if it were the student's own work done expressly for that particular course when, in fact, it is not. Most commonly plagiarism exists when:

- (a) the work submitted or presented was done, in whole or in part, by an individual other than the one submitting or presenting the work (this includes having another impersonate the student or otherwise substituting the work of another for one's own in an examination or test),
- (b) parts of the work are taken from another source without reference to the original author,
- (c) the whole work (e.g., an essay) is copied from another source, and/or,
- (d) a student submits or presents work in one course which has also been submitted in another course (although it may be completely original with that student) without the knowledge of or prior agreement of the instructor involved.

While it is recognized that scholarly work often involves reference to the ideas, data and conclusions of other scholars, intellectual honesty requires that such references be explicitly and clearly noted.

Plagiarism occurs when direct quotations are taken from a source without specific acknowledgement, or when original ideas or data from the source are not acknowledged. Citing your sources in a bibliography is not enough, because a bibliography does not establish which parts of a student's work are taken from other sources. MLA (Modern Language Association) documentation or other recognized forms of citation must be used for this purpose. Advice on adequate documentation can be found at the following web sites:
