ENGLISH 483 LO1 Literary Theory Since 1800

Course Description:

In this course students will acquire an introduction to and in-depth acquaintance with four new theoretical areas: ecocriticism, animal studies, indigenous theory, and bioregionalism. Although our first and major focus will be on the theoretical writings of our texts, and while resisting the binary between "theory" and "application," we will also examine a few short texts and excerpts that allow us to explore when and how we might deploy a given theoretical approach or principle.

Required Texts (in the order in which we will study them):

Cheryll Glotfelty and Harold Fromm, eds., *The Ecocriticism Reader: Landmarks in Literary Ecology*
Dawne McCance, *Critical Animal Studies*
Neal McLeod, ed., *Indigenous Poetics in Canada*
Liza Piper and Lisa Szabo-Jones, eds., *Sustaining the West: Cultural Responses to Canadian Environments*

You must also possess a writing and style (MLA Style) manual such as but not restricted to *The MLA Handbook for Writers of Research Papers*. This is the standard manual for work in literary studies. If you already have another writing, grammar and punctuation manual, it might be adequate. If you do not have one at all, then I would suggest you purchase *The MLA Handbook for Writers of Research Papers*.

* This assignment is conceived along the lines of a conference panel. Each participant will speak for two minutes (timed), and then there will be a dialogue among the panel participants, followed by time for two or three questions from the rest of the class. Length of the individual presentation portion of the panel discussion (2 minutes) is calculated as the time required to read aloud two typed double-spaced pages of print. I provide this figure here simply in order to help you assess how much material one can present in two minutes. You need not read your oral presentation. Total time for the entire panel is 20 minutes. There will be a sign-up sheet for presentation topics and dates in week 2 of the course.

** In conjunction with community engagement within literary studies, students will attend a literary reading (or more than one, if you like) during Wordfest 2015 and write about that event. After all, if it were not for creative writing, there would be no English students, English professors or English Departments, right? Moreover, one of the supreme pleasures of studying literature is to become engaged with and even actively involved in the literary communities in Calgary, Alberta, Canada, and beyond. Support some of the writers who make your chosen field, your studies and future career and lifestyle possible. See the Wordfest website for information and tickets: <http://wordfest.com> Some of the readings are free, while others carry a modest charge. You might need a ticket even for the free events: consult the site.

Students may choose either a) to write a review of the event (a review along the same lines of a movie, dance or theatre review – if you’ve never read a review, consult the local newspaper reviews on the weekend and those in the *Saturday Globe and Mail* or other newspaper or relevant magazine) OR b) to write a mini-essay of the same length (3 pp.) exploring ONE of the following questions: what role do literary readings play in the reception of literary works; how does your study of literary theory connect with the reading of writers of their own work; how do private acts of reading (and writing) come together in a public event such as the reading you attend?

SOME MORE IMPORTANT NOTES:

Students must complete and submit in a timely fashion all of the assignments in order to be eligible for a passing grade for this course. Failure to complete them may result in an automatic failure of the course (F).

Similarly, failure to show up for your own oral presentation will constitute failure to complete all of the assignments for the course and may also result in an automatic failure of the course.

Students experiencing distress or having extenuating personal reasons for lateness or protracted absences should contact the instructor as soon as possible.

There will NOT be a registrar-scheduled examination in this course. The final examination will be of the take-home, open-book format. The final examination is due **no later than noon on Monday, Dec. 14th. Failure to submit it to the English General Office, 11th floor, SS, before noon on that day will result in an automatic failure of the assignment and the course.**

Page lengths for written assignments are calculated on the following basis: All written assignments must be double-spaced in 12-point font with 1" margins on all four sides of the page.

Late penalties: Late penalties will be deducted for late assignments. Late penalties can and sometimes do result in a failing grade on an assignment so students will want to start assignments well in advance of any due date. **The late penalty for written work is one mark per day late.** That is, if your assignment merits a 20/25 (80%, A-) but comes in two days late, the mark will drop two marks to 18/25 (76%, B). This measure is in place in order to ensure a level playing field for everyone in the course.

This course will be conducted as a mixture of lecture, class and group discussion, groupwork, workshop, fieldwork, applied readings, exercises (for instance, possibly some impromptu skit creation, audio recording, and other creative opportunities for class participation), and other forms of learning. Students will have hands-on, and some community-based, engagement with literary theory through various exercises and assignments (such as attending and reporting on a literary reading during Wordfest in October). Participation in all learning activities, not just lectures, is compulsory.

Why? Because learning theory is akin to learning a new language. When you study a language, you also learn how to speak that language, not just read it or read about it. Moreover, an important part of intellectual work is being able to speak about it with others. There is little point in hoarding your insights by keeping them to yourself: the world needs them, as we shall see as we read and think about the course materials. In short, students will be expected to assume the role of active participants in the construction and dissemination of knowledge rather than that of merely passive consumers of it. This includes participation in discussion and in credit-free assignments and activities carried out in class.

A strong commitment to class attendance, completing the assigned readings in advance of the class for which they are scheduled, avidly participating in all class and group discussions and in-class exercises and activities, demonstrating respectful and open intellectual engagement with the course materials and with fellow students and the professor are highly valued. Intermittent attendance (more than a couple of absences per term) *always* results in losing one's place in terms of the material and the others in the course. We will have a lot of fascinating material to talk about, work on and play with in this course! Think of a course not as a marks factory but as a community of living, thinking, responding, researching, knowledge-creating beings.

Recent studies have shown that handwritten class notes are markedly superior in terms of acquiring a more thorough understanding of course material and for retention of material in one's memory. The instructor reserves the right to outlaw the use of phones, tablets and computers in class. Surfing the web, checking email or social media, or taking calls or texting during class is strictly forbidden (unless of course instructed to do so by the professor for pedagogical purposes).

Along similar lines, I highly recommend that you annotate and underline the primary course texts (preferably in paper, but you can annotate in ebook and electronic articles in formats such as the Kindle application). Don't try to preserve pristine copies of your texts for resale to other students who will underline and annotate and therefore do better than you did in the course! As proven in numerous studies of learning processes, reading your underlining and annotations are the best ways of acquiring and consolidating your knowledge of textual material. Studying is also vastly easier if you have already 'made tracks' in your text (though not, of course, in any library books).

Please do not attempt to read the assigned materials on your phone! You cannot possibly ingest the texts on a screen as small as that of a phone. Just as visual arts courses examine the quality of the paint strokes in a painting or the forms in clay, literary studies are based on engagement with the language of the text. We are not studying course materials for an entire term simply in order to extract "the main idea" or "the general drift" of a text! We will be focussing on what is actually on the page. You must therefore bring the assigned readings of the week to class.

Sources of information about additional literary readings and book launches include the English Department website, in-class announcements, *Swerve Magazine* (published with the Friday edition of the *Calgary Herald*), and individual bookstore's websites (see ShelfLife and Pages Books, for example).

There will be no extra credit assignments or opportunities to re-do and resubmit your work. That being said, if you need some help or advice with anything course-related, please visit me in my office during office hours, and I will be very pleased to assist you.

Double-sided printing of assignments is highly encouraged in order to save paper and trees. Please feel free to use factory recycled paper or even paper that has already been used on one side only. This is not only permissible but admirable. Just draw a line diagonally through the material printed or written on the “wrong” side and make sure your pages are stapled in order.

Please **DO NOT** use any plastic cover sheets for your assignments. They have an annoying tendency to flap shut while one is trying to read them, and using plastic contributes to waste, pollution and excess carbon. Just a simple staple in the upper left-hand corner of the page is perfect. Please staple your work before handing it in. I do not usually carry a stapler with me to and from class.

Written assignments are due at the beginning of class on their respective due dates, and they must be physically handed to the instructor. At this point, I cannot accept any electronic submissions (which is too bad as it would save paper and trees). If you absolutely cannot hand me your work in class, then do not shove your professional work under my (or anyone else’s) office door. It can and does get trampled, lost, put under the wrong professor’s door, etc. Instead hand them in via the English Dept. office between 8:30 and 4:30 (the office is closed from 12:00 to 1:00) or the Essay Drop Box just outside the English Department office. NOTE: The English Office is on the 11th floor of the Social Sciences Bldg.

PLAGIARISM

Plagiarism is an extremely serious offence. Please read the following information carefully. The penalty routinely recommended by the English Department for documented plagiarism is failure of the course in which the offence occurred; academic probation is also routinely applied at the Faculty level. Suspension or expulsion can result from severe or repeated plagiarism.

The University Calendar states:

1. Plagiarism - Essentially plagiarism involves submitting or presenting work in a course as if it were the student's own work done expressly for that particular course when, in fact, it is not.

Most commonly plagiarism exists when:

- (a) the work submitted or presented was done, in whole or in part, by an individual other than the one submitting or presenting the work (this includes having another impersonate the student or otherwise substituting the work of another for one's own in an examination or test),
- (b) parts of the work are taken from another source without reference to the original author,
- (c) the whole work (e.g., an essay) is copied from another source, and/or,
- (d) a student submits or presents work in one course which has also been submitted in another course (although it may be completely original with that student) without the knowledge of or prior agreement of the instructor involved.

While it is recognized that scholarly work often involves reference to the ideas, data and conclusions of other scholars, intellectual honesty requires that such references be explicitly and clearly noted.

Plagiarism occurs when direct quotations are taken from a source without specific acknowledgement, or when original ideas or data from the source are not acknowledged. Citing your sources in a bibliography is not enough, because a bibliography does not establish which parts of a student's work are taken from other sources. MLA (Modern Language Association) documentation or other recognized forms of citation must be used for this purpose. Advice on adequate documentation can be found at the following web sites:
