

Required Assignments:

Portfolio: Learning/Reading Responses (5 x 5% = 25%)

The Portfolio: Learning/Reading journal will consist of responses, reflections and exploratory writing. The journal will help you to develop your critical reading and writing skills as well as assist you to keep up-to-date with course readings and prepare for class discussions.

Media Reflection Response (20%)

The purpose of the assignment is to enhance your critical awareness and apply your knowledge to the broader social context. Choose a social media text (newspapers, blogs, articles, images/photos, music videos, etc) that engages with international indigenous people from one of the four regions we are discussing in the course. In this essay of 1200 – 1500 words, you will critically analyze and discuss the meaning of the social media text. Rather than reading only for information, read for *ways of thinking* about the subject matter. Your goal is to critically analyze the text carefully for its representation markers of race, gender, religion, race, class, culture, sexuality or language. Include a copy of the social media text with your essay.

Course Project (30%)

The course project will require external research and at least 10-12 pages of written work. Students must meet with me to discuss their course project in order to receive a grade in the course. The course project is an individual project.

Some examples of course projects are:

- Write a research paper on an international indigenous writer from one of the four regions and how they have contributed how indigenous stories convey worldviews and truths often unfamiliar or hidden from mainstream and non-indigenous audiences.
- Inter-art or Interdisciplinary Project. Include a log (10-12 pages) reflection on the process you undertook.
- Research any two films, novels, documentaries, biographies, art work, musical work etc. on an international indigenous writer from one of the four regions and write a comparative essay.

Presentation based on Course Project (15%)

The presentation will be based on the course project and you will serve as a discussion leader. The presentation is to provide you with feedback on your course project and is designed to strengthen your analytical and critical reading skills, improve your oral communication skills and build your confidence. Students will sign-up for a presentation time mid-way through the course.

Participation (10%)

Students are responsible for all information covered in lectures and class discussions. Class participation involves not only attending class, but reading/viewing all assigned materials and **coming to class prepared to discuss them**. Your engagement with the readings, discussions, and activities for this course will greatly influence your success in the course.

The instructor will not, as a rule, provide lecture notes or a summary of the class activity and discussion, except in the case of those students who have accommodations from Accessibility Services for such support.

Use MLA citation. Students must use MLA citation style for all assignments. Assignments must adhere to length requirements dictated for each assignment.

Late Assignments:

Assignments submitted after the deadline will be penalized with the loss of a third of a grade (an A- to B+) for each business day [not class] that the assignment is overdue.

Submission and Return of Written Assignments

Please make every effort to take assignments directly to the instructor. If it is not possible to do so, take your assignment to SS 1152 and put it in the dropbox. Your assignment will be date-stamped and placed in the instructor's mailbox. It is your responsibility to keep a copy of all assignments in case of loss by any cause. Assignments cannot be returned by staff in the Department office.

Students may submit most or all the assignments electronically, (but not by e-mail) or paper copies of all assignments and presentations. Submit on-line on to *D2L*.

You are welcome to use your laptop in class. However, as a simple courtesy to the instructor and to others in the class, please do not use electronic devices for purposes not directly related to the class. Audio or visual recordings are not permitted.

Grading system:

PLAGIARISM

Plagiarism is an extremely serious offence. Please read the following information carefully. The penalty routinely recommended by the English Department for documented plagiarism is failure of the course in which the offence occurred; academic probation is also routinely applied at the Faculty level. Suspension or expulsion can result from severe or repeated plagiarism.

The University Calendar states:

1. Plagiarism - Essentially plagiarism involves submitting or presenting work in a course as if it were the student's own work done expressly for that particular course when, in fact, it is not. Most commonly plagiarism exists when:

- (a) the work submitted or presented was done, in whole or in part, by an individual other than the one submitting or presenting the work (this includes having another impersonate the student or otherwise substituting the work of another for one's own in an examination or test),
- (b) parts of the work are taken from another source without reference to the original author,
- (c) the whole work (e.g., an essay) is copied from another source, and/or,
- (d) a student submits or presents work in one course which has also been submitted in another course (although it may be completely original with that student) without the knowledge of or prior agreement of the instructor involved.

While it is recognized that scholarly work often involves reference to the ideas, data and conclusions of other scholars, intellectual honesty requires that such references be explicitly and clearly noted.

Plagiarism occurs when direct quotations are taken from a source without specific acknowledgement, or when original ideas or data from the source are not acknowledged. Citing your sources in a bibliography is not enough, because a bibliography does not establish which parts of a student's work are taken from other sources. MLA (Modern Language Association) documentation or other recognized forms of citation must be used for this purpose. Advice on adequate documentation can be found at the following web sites:
