## **Official Course Description**

Environmental and resource issues, with emphasis on topics such as climate change, sustainability, ethics, planning, policy and decision making, and management strategies. Case examples highlight issues in resource sectors such as freshwater, oceans, parks and wildlife, tourism and recreation, forests and energy.

# **Course Objectives**

In Calgary, we have become accustomed to thinking about society-environment relations in particular ways, which has some linkages with the region's overwhelming economic dependence on the energy industry – and oil and gas, specifically. Most of these conceptions feel very common-sense to us, so much so that it's difficult to see where they come from, their assumptions, and implications. In this course, we will (1) develop tools to step back and think critically about society-environment changes, (2) learn how geographers leverage particularly *spatial* frameworks for analyzing society-environmental relations, and (3) gain a deeper understanding of the global and local dynamics driving the current global climate crisis.
