## **Official Course Description**

An introduction to the major concepts of human geography including demography, migration, cultures, languages, and religions.

# **Course Objectives**

This course is an introduction to the sub-disciplines and topics surrounding Cultural and Social Geography. A primary objective is to evaluate how social and cultural elements influence spatial characteristics of human activities and behaviors. These objectives are implemented through the integration and application of real-world examples and case studies.
