# **Learning Technologies and Requirements**

All term tests/exams will be administered via the D2L 'quizzes' module. Students will receive 150% of the exam time that would have been provided had we been teaching in-person. Therefore, the length of the term tests will now be 75 minutes and the Final Exam will be 180 minutes in duration. Students will be allowed to complete all test and exams for a 24-hour period on the 'day' of the test/exam (beginning from midnight of Oct 11<sup>2h</sup> to midnight of Oct 13<sup>th</sup> and midnight of Nov 16<sup>th</sup> to midnight of Nov 17<sup>th</sup>.

The final examination date will be scheduled by the Registrar's Office and the exam will be administered through D2L quizzes.

It is not essential to pass all components to pass the course as a whole.

Late assignments without prior arrangement will be penalized 20% per day.
