# **Official Course Description**

Exploration of the challenges associated with environmental management and governance, particularly in terms of achieving sustainability. Emphasis is placed on ongoing local, regional, and global environmental problems, using political ecology perspectives to understand power, discourse and interest mechanisms behind environmental rights, controls, and sustainability needs.

## **Course Objectives**

The course expands on key concepts, knowledge and different perspectives on socio-political systems and contemporary environmental problems, with a critical focus on sustainability and power aspects of environmental issues.

## **Assessment Methods**

- 20% Tutorial activities and assignments
- 30% Midterm (Feb 17-18)
- 15% Sustainability project
- 35% Final exam (tba; registrar-scheduled)
  - Tutorial activities and assignments include in-session participation during synchronous tutorials for exercises, discussion, group work, as well as take-home assignments and short presentations. Tutorial attendance and full interactive engagement are required.
  - Midterm will be 75 minutes plus technical allowance = 110 minutes. It will be a D2L-based online exam accessible
    for one attempt within a 24-hour access window from Thu Feb 17 2pm to Fri Feb 18 2pm. It is an open-book exam
    permitting all GEOG 428 W22 course materials. Absolutely NO contact or collaboration allowed between students
    on the scheduled exam days, and no external support related to exam questions.
  - Sustainability project focuses on a chosen sustainability topic to be developed over the semester as an individual or group project. Grading components include presentations during tutorial sessions, written materials, as well as short video recordings to be shared with the class.
  - **Final exam** will be 90 minutes plus technical allowance = **135 minutes**. It will be a D2L-based online exam accessible for one attempt within a 24-hour access window, to be **registrar-scheduled** during the W22 final examination period. It is an open-book exam permitting all GEOG 428 W22 course materials. Absolutely NO contact or collaboration allowed between students on the scheduled exam days, and no external support related to exam questions.

Accommodation requirements through Student Accessibility Services still apply. The time allocated for issues that arise during an assessment would be in addition to accommodation requirements. See Section **G (Examination and Tests)** for additional details.

In advance of the timed midterm and final exam assessments, Q&A office hours will be posted on D2L for any questions outside of the scheduled class time.
