Official Course Description

Conceptualizing human-environment realities into research: an introduction to philosophical foundations of ways of thinking and critical perspectives; qualitative and mixed methods approaches. Examination of 'rules' of research and the challenges of real world complexities. In-depth examples of human-environment research from theory to practice, broad research design and proposal writing practice.

Course Objectives

An exploration of the practice used by geographers to observe, measure and interpret human-environment-animal relationships in the world (i.e. ways of knowing). A key objective is to expose students to alternative ways of collecting data than they may have been exposed to in their specializations (e.g. media, art, expert knowledge, decision support, univariate and multivariate regression, traditional ecological knowledge) to understand complex geographic relationships. The assignments engage critical reflecting on the nature of methods used and knowledge gained. In sum, the course focuses on applying theory to practice, explores qualitative to quantitative methods, with a goal of opening students up to alternative ways of "knowing" geography.

Prerequisites

3 units from UBST 253 or GEOG 300 level or above.

Experience in either basic qualitative or quantitative analysis is helpful. The following are required:

- Use of online technology (i.e., D2L, Zoom, Yuja), and Office Suite (i.e. PowerPoint, Word, Excel, or equivalent software) will be required to participate in the course and complete assignments;
- Ability to communicate verbally (e.g., with classmates, instructor and TA, both online and in person) and by written communication (e.g., using D2L and email);
- Internet capacity to access online materials, communicate with instructor and classmates, and upload completed assignments.

Course Format

- The majority of lectures will be on-campus, in-person lectures during the scheduled lecture period (Tuesdays 3:30-6:15 pm). These lectures will NOT be recorded, but lecture slides will be available on D2L.
- **Three lectures will be cancelled (September 6, 20, and 27) and replaced with online asynchronous lectures. There will be no in-person lectures these weeks (Weeks 1, 3, 4).**
- Tutorial assignments will be introduced during lectures, with slides and assignments posted on D2L. Tutorial periods are a good time to meet with your tutorial partners, but they are not formal tutorial periods and attendance is not mandatory.
- There will not be any course activities scheduled outside of the lecture and tutorial periods.
