## **Official Course Description**

Seminar-style overview of core readings, key concepts and central debates in science, technology and society (STS) in Geography. Considers mutual shaping of science, technology and society as context-dependent practices involving institutions and discourses that vary across regions and time. Themes include social construction of knowledge and technology, agency, networks, co-production, expertise, authority, legitimacy, and democratic engagement. Empirical cases at global, national, and regional scales illustrate key concepts and debates.

#### **Course Objectives**

Complex scientific and technological issues face our world today, including the effects of AI, digital surveillance, genomics, and bio-digital convergence. In light of hype and promises to address social problems, technoscientific innovations present ethical, political, and legal challenges. Geographers, and critical scholars more generally, use a range of theoretical and empirical approaches to examine issues at the science-technology-society interface. This course introduces students to geographical thinking about technoscience by integrating critical thinking, values, and social and environmental responsibility into analysis.

# **Grading (Weighting)**

#### Seminar presentation

10% of final grade

Overview: Working in small groups, students will summarize key points and concepts from assigned readings through a 10-minute class presentation. Presentation topics and dates will be assigned during the first weeks of class. Due: Exact dates TBA - range between January 22 and March 20, 2024. All members of group receive the same grade.

#### Research project

60% of final grade

Overview: The research project consists of independent research into a case study of technology in society. Evaluation for the project is based on three components: proposal, presentation, and final report. Students have option of working individually or in small groups. If working in small group, all members receive the same grade.

Proposal (5% of research project grade)

Written overview of research project topic that includes justification / significant, research questions, and annotated bibliography of potential research sources (minimum 5, up to 10). Due: February 16, 2024 by 11:59PM (D2L submission)

Presentation (30% of research project grade)

Students provide a 10-minute video recorded presentation of research project. Videos will be shown in class between March 25 and April 8, 2024 Due: March 24, 2024 by 11:59 PM (D2L submission)

Final research report (65% of research project grade)

A written essay outlining significance, research question (s), background, methods, key findings, and recommendations. Length: 4000 – 5000 words, double spaced, excluding abstract, table of contents, images, references. Equivalent outputs (e.g. podcast, documentary) acceptable but must be approved in advance by instructor. Due: April 8, 2024 by 11:59 PM (D2L)

# Participation

30% of final grade

Overview: Participation assignments evaluated using pass-fail: Fail (0 = unsatisfactory), Pass (1 = meets expectations; 1.25 = exceeds expectations).

Participation assignments include:

- Reading responses: Written responses and reflections on readings. Five in total. Submitted to discussion board on D2L. Due Monday by 9:00 AM on weeks 2, 3, 4, 5, 6. Worth up to 60% of participation grade.
- Active participation in class discussions (Consistent, thoughtful, and constructive participation in class discussions, 40% of participation grade). Throughout



#### Additional:

- There is no final examination in the course.
- It is **not** essential to pass all components to pass the course as whole.
- Late assignment policy: Assignments will be docked one letter grade (e.g. A to A-) for each class day late. For instance, if assignment is due on Friday, but submitted the following Monday, the assignment would lose one letter grade. If submitted on Wednesday, two letter grades would be lost. Reading responses must be completed by due date indicated: late responses will not count toward evaluation.
