Official Course Description

Surveys GIS applications for urban studies, and the data structures, sources, and analysis techniques used in them. Explores urban spatial analysis, decision-making in a GIS environment, and representational challenges, including project planning, spatial data acquisition, data preparation and coding, analysis and visualization of project findings, and communication and implementation of project results.

Course Objectives

This course builds on your previous introductory- and advance-level coursework in GIS, through a more in-depth examination of GIS applications in urban studies, and the data structures, source, and analysis techniques used in them. Through collaborative partnerships with urban professionals from the City of Calgary, University of Calgary, and Sustainable Calgary, students will work on real-world project (modules) that require GIS solutions. These projects are designed to mirror professional urban GIS challenges, providing hands-on experience and practical application of GIS skills in addressing current urban issues.

Through the projects, we will explore urban spatial analysis, decision-making in a GIS environment, and representational challenges, including project planning, spatial data acquisition, data preparation, analysis and visualization of project findings, and communication and implementation of project results. Students will gain experience in locating and obtaining geospatial data from local, provincial, and national government sources; developing primary data for urban spatial analysis; and analyzing and representing these data using desktop GIS software. We examine a range of urban applications of GIS, including accessible voting for the City of Calgary, sustainability, and transportation and routing application.
