Official Course Description

Topics include descriptive statistics, probability theory, sampling design, inferential statistics, model validation and assessment of uncertainty, and applied multivariate analysis. Techniques and examples emphasize the use of geospatial data for constructing models of geographic phenomena and spatial problem-solving.

Course Objectives

The objective of this course to provide students with fundamental concepts, theory and application of statistical terminology, assumptions, and test procedures, which help address questions pertaining to human, physical and urban geography. By the end of this course students should hold fundamental knowledge of the use and limitations of basic statistical analyses and inferential testing procedures using multivariate datasets acquired at various data levels.

Prerequisites

Admission to the Graduate Certificate in Geospatial Information Technology or consent of the Department.

Course Format

The course is asynchronous.

Learning will occur asynchronously, i.e., lectures and lab presentations will be posted in the form of videos that students can watch in their own time. Both the instructor and the teaching assistant will offer synchronous contact time, i.e., each of them will be available for a scheduled time each week to discuss course material and address student queries. Students are encouraged to attend synchronous sessions. Dedicated discussion channels will also be available.

In order to obtain the minimum graduate level passing grade (B-), *students must obtain no less than 70% in each of the following course components:*

1. Total sum of all the labs;
2. Total sum of Quiz 1 and Quiz 2;
3. Total sum of all the project deliverables (proposal, written report, and presentation).

Lab exercises are due at 8.00 a.m. MDT/MST on the due date specified in the class calendar, i.e., one week after the lab is assigned (unless otherwise specified).

The final project is an opportunity to perform an insightful statistical analysis on a research topic chosen by each individual student. Detailed guidelines for the project completion will be provided in class. The final project (written report and presentation) must be consistent with the project proposal. If the final project is not consistent with the proposal, the proposal will receive a 0 grade.

Late Policy:

Lab assignments, project proposal, and final project report and presentation are due on the date specified above, as well as in the calendar provided in class. They are due at 8.00 a.m. MDT/MST on that date. There are no exceptions and any piece of work handed in late will be subject to an immediate 10% penalty followed by a 10% reduction in grade for each day thereafter (weekends and holidays included). **Medical related circumstances will require a note from a physician.** 

Appropriate documentation shall be provided in support of other circumstances.

There is no final exam for this course.

Only pens, pencils and erasers are allowed in exams. No other materials or devices are allowed.

Students are only permitted to use the software/tools required for each activity, e.g., zoom, or statistical software. The use of any other device, software or tool is not permitted.

Timed Assessments for Online and Blended Courses

Students will be provided with a 24-hour window in which they can access and complete a timed online assessment, except in those cases where prior approval has been obtained from the Dean of the faculty offering the course to host a synchronous assessment where students start and end at the same time (i.e. a common assessment time).

Contingency plan. In the event of a malfunction or other issue preventing a student from completing the timed assignment, the student must immediately contact the instructor by email, detailing the nature of the problem, the time of occurrence, and the portion of the assignment that could not be completed. Depending on the above circumstances, the instructor, at her discretion, will provide one of the following options: a make-up test administered at a mutually agreed time, an oral exam administered at a mutually agreed time, or a grade weight adjustment. Should the student fail to communicate immediately the problem to the instructor, no contingency plan will be implemented, and the student will be graded on the work they submitted.

Guidelines for Zoom Sessions

Zoom is a video conferencing program that will allow us to meet at specific times for a "live" video conference, so that we can have the opportunity to meet each other virtually and discuss relevant course topics as a learning community.

To help ensure Zoom sessions are private, do not share Zoom link or password with others, or on any social media platforms. Zoom links and passwords are only intended for students registered in the course. Zoom recordings and materials presented in Zoom, including any teaching materials, must not be shared, distributed or published without the instructor's permission.
