Official Course Description

Introduction to urban gender issues from historical and spatial perspectives. Issues such as the gendering of urban design and planning, daily urban activities, urban labor markets, urban politics, gentrification, suburbanization and identity construction in urban spaces are addressed.

Course Objectives

The primary objective is to interrogate the intersection of urban space, spatial phenomena and processes, and the role of power relations in shaping the lived experiences of space. This course is designed to develop advanced skills of observation, critical reflection, problem identification, and problem solving to prepare students to address the spatial and mobility needs and priorities of different urban populations. The course will broaden students' awareness, knowledge, and response to spatial change, policy, planning, and the engagement of diverse and marginalized populations in urban outcomes.
