In determining the overall grade in the course the following weights will be used:

Component(s)	Weighting %	Date
Midterm 1	30%	Asynchronous. Students will be given 112 min to complete a 75 min exam, with a 24-hr window of time. October 6.
Midterm 2	30%	Asynchronous. Students will be given 112 min to complete a 75 min exam, with a 24-hr window of time. November 3.
Final Exam	40%	Registrar-scheduled. Asynchronous. Students will be given 3 hrs to complete a 2-hr exam, due at the end of the scheduled exam time.

Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. The student's grade for each component listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade.

The conversion between a percentage grade and letter grade is as follows.

Midterms and Final exams will be conducted through D2L, with a 24-hour window in which students can write the timed exam. There should be no communication between students and no outside resource use (e.g. internet or lecture slides) during the exams.

- Develop a defensible model for environmental challenges in the evolution of earlier life forms on Earth
- Operate with basic concepts of geology, such as minerals and mineral groups, major rock types and rock cycle, and geological time.
- Develop a defensible model for the calculation of the age of the Earth.
