#### **Course Outcomes:**

- Describe the major morphogeological belts of the Canadian Cordillera, in terms of formation and main rock types.
- Develop and explain the concept of old rocks, intermediate tectonics, and young landscape.
- Detail the importance of glacial processes in the Cordillera, in terms of erosion and deposits.
- Apply their knowledge of Cordilleran geology in order to describe where metallic mineral deposits and fossil fuels are located.
- Explain the current tectonic setting of western Canada, and the relation between this tectonic setting and volcanism, earthquakes, and mass movements.
- Outline the main geological features of the Rocky Mountain parks.
- Describe several areas of current scientific research in the Cordillera, and how this research impacts society and our understanding of earth processes.
- . Link the geological setting of Calgary to the history of mountain building.
