Online Delivery Details:

This course is being offered online in real-time via scheduled meeting times, you are required to be online at the same time.

To help ensure Zoom sessions are private, do not share the Zoom link or password with others, or on any social media platforms. Zoom links and passwords are only intended for students registered in the course. Zoom recordings and materials presented in Zoom, including any teaching materials, must not be shared, distributed or published without the instructor's permission.

This course has a registrar scheduled, synchronous final exam. The writing time is 2 hours + 50% buffer time.

Lectures: Lectures are delivered synchronously online via Zoom and run Monday/Friday 2:00-2:50 PM. Lecture slides will be provided via PDF on D2L. No pre-recorded lectures will be provided, and lectures will not be recorded.

Tutorials: Tutorials are delivered synchronously online via Zoom every Wednesday from 2.00 - 2.50 PM. Tutorial materials will be made available through D2L. Students will need a mobile device or laptop to access the tutorial content. Tutorials will not be recorded.

All questions regarding the tutorials should be directed to the TA during the scheduled online tutorial times

Students are expected to attend all lectures and tutorials via Zoom.

¹ Tutorials begin the week of January 23. Tutorial sessions run on Wednesdays from 2:00-2:50 pm via Zoom. Each of the eight (8) weekly tutorial assignments must be submitted via D2L on Fridays by 5 PM, with the first due date occurring on Friday, January 27.

² The midterm exam is designed to be completed in 50 minutes. There will be 50% buffer time for technical issues, so the total length of the exam is 75 minutes. Students will have 24 hours in which to access the exam, starting at 2:00 pm on February 27.

Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. The student's grade for each component listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade.

The conversion between a percentage grade and letter grade is as follows.

This course will have a Registrar Scheduled Final exam that will be delivered on-line. [The Final Examination Schedule](#) will be published by the Registrar's Office approximately one month after the start of the term. The final exam for this course will be designed to be completed within 2 hours.

Per section [G.5](#) of the online Academic Calendar, timed final exams administered using an on-line platform, such as D2L, will be available on the platform. Due to the scheduling of the final exams, the additional time will be added to **the end** of the registrar scheduled **synchronous** exam to support students. This way, your exam schedule accurately reflects the **start time** of the exam for any **synchronous** exams. E.g. If a **synchronous** exam is designed for 2 hours and the final exam is scheduled from 9-11am in your student centre, the additional time will be added to the **end** time of the **synchronous** exam. This means that if the exam has a 1 hour buffer time, a synchronous exam would start at 9 am and finish at 12pm.

There will NOT be any bonus grades or extra assignments available to boost grades. Requests for rounding of final percent scores will NOT be approved.

David E. Fastovsky and David B. Weishampel, *Dinosaurs: A concise natural history (3rd or 4th edition)*: Cambridge University Press.

The recommended textbook provides an immense amount of background and extra materials. However, I understand that students may not wish to spend money on a book outside of their major, so you should be able to succeed in this course if you work only from the provided lecture materials.
