3. Grading:

- Lab. Assignments (including wooden models) 10% (September 6- December 6, 2019)
- Theory Midterm 15% (October 18, 2019)
- Lab. Midterm 15% (week of October 22, 2019)
- Lab. Final 20% (week of December 3, 2019)
- Theory Final 40% (to be scheduled by the registrar)

Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. The student's grade for each component listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade.

The conversion between a percentage grade and letter grade is as follows.
