2. Requisites:

Antirequisite(s): Credit for Geology 441 and 639 will not be allowed.

Notes: This course occurs in rugged field conditions and varying weather, for which participants must be prepared and equipped. A supplementary fee will be assessed to cover additional costs associated with this course. Students will require consent of the department to drop this course.

3. Grading:
