To account for any necessary transition to remote learning for the current semester, courses with in-person lectures, labs, or tutorials may be shifted to remote delivery for a certain period of time. #### **In Person Delivery Details:**

This course is offered as an in-person class only. Some lectures will be given by guest lecturers including Dr. J.-H. Kim, a leading expert in Contaminant Hydrogeology.

The course has a registrar scheduled final exam. The writing time is 2 hours.

The midterm exam is scheduled during lecture hours on March 2, 2023. The writing time is 75 minutes.

Lecture notes will be posted on D2L, whenever possible prior to the lecture.

Students will conduct a brief literature review on a contaminant of their choice and give a presentation to the class about a contamination hydrogeology case study. Student presentations time slots are scheduled throughout the term.

- Develop site conceptual models to evaluate groundwater contamination
- Describe various remediation approaches to address groundwater contamination
- Research and Present a contaminant hydrogeology case history
