## Course Outcomes

- Analyze and integrate structural data within a tectonic framework or general stress field
- Synthesize structural information to predict aspects of structural geology in the subsurface (3-D visualization).
- Comprehend the aspects of structural style, what factors control the style and incorporate the style into an

interpretation

- Describe the general strain path of an observed structure from the incipient state to present day
- Produce a balanced cross-section, a section that is kinematically viable and admissible
- Evaluate the quality and limitations of a structural geology interpretation. For example - Practice qualitative evaluations of existing geologic cross-sections and maps
- Gather structural data from a variety of data sources and evaluate the veracity and limitations of the data
