Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. For Geologists: Sharp, Z. (2007): Stable Isotope Geochemistry. Pearson Prentice Hall, Upper Saddle River NJ (~\$100).

For Physicists: Criss, R. E. (1999): Principles of Stable Isotope Distribution. Oxford University Press New York (US\$ 69).

For Ecologists: Fry, B. (2006): Stable Isotope Ecology. Springer, New York (\$60)

Some of these books are on reserve in the Gallagher Library throughout the winter term.
