**Online Delivery Details:**

This course is being offered online in real-time via scheduled meeting times, you are required to be online at the same time.

This course is being offered online in real-time via scheduled meeting times, you are required to be online at the same time. Because this is a team-based course, with each team consisting of a number of geoscientists and engineers, the team will decide on the weekly meeting time that works for all + the co-instructors and TA. Once the meeting times are set, all team members are required to attend online at the scheduled weekly time. At each weekly meeting, which will be scheduled for 1.5 hours, a team-representative will present on the progress of the team for each week, and the team will be asked questions and, given feedback and advice, by the co-instructors and the TA. The weekly sessions will be recorded. Recordings will be available via the course D2L page.

3. **Grading:**

In determining the overall grade in the course the following weights will be used:

\*A student must pass the oral exam to receive a grade of C- or higher in the course. If a student does not pass the oral exam, the maximum grade earned is D+.

Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. The student’s grade for each component listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade.

The conversion between a percentage grade and letter grade is as follows.

Weekly presentations (synchronous), scheduled at a time decided upon by each team (see 'Online Delivery Details'), will be used as the basis of the 'Weekly Presentations' component of the grade. A rubric will be supplied to the team the week before their first weekly presentation so that they understand the components they will be graded on.

Final student oral exams (held online) will occur during the week of April 12, 2021. The day for each team will be selected by the team, and the timeslot for each team-member will also be decided upon by the team. The oral exam will have a duration of 1 hour. Students will be informed of the general structure of the oral exam, and the areas they will be examined on, prior to the first weekly presentation.

#### 4. **Missed Components Of Term Work:**

The university has suspended the requirement for students to provide evidence for absences. Please do not attend medical clinics for medical notes or Commissioners for Oaths for statutory declarations.

In the event that a student legitimately fails to submit any online assessment on time (e.g. due to illness etc...), please contact the course coordinator, or the course instructor if this course does not have a coordinator to arrange for a re-adjustment of a submission date. #### 7. **Examination Policy:**

The following examination will be held in this course:

Individual oral exam (1 hour, during week of April 12, 2021) covering reservoir characterization procedures and all aspects of the work done by the team to characterize the field studied.

The exam will be assessing the individual for the following:

1. Detailed, in-depth understanding in one area (geology, geophysics, petrophysics, reservoir engineering) and its importance to the other areas
2. Detailed understanding of another area and its importance
3. Overview understanding of the other two areas and their importance
