- Understand the structure of the Earth, and how this influences natural hazards on Earth.
- Describe the timeline of events of several historical natural disasters as case studies.
- Understand the human influence on natural disasters, and understand how society deals with natural
- disasters in terms of forecasting, planning, dealing with the aftermath and mediating such events.

The reappraisal will only be considered if the student provides a detailed rationale that outlines where and for what reason an error is suspected.
