Project building using makefiles. Development of Linux tools in C. Creating libraries.

Examples using open source software Seismic Unix: creating synthetic seismic data, Radon transforms, adaptive subtraction.

Project building using Scons (Python). Object-Oriented Programming in C++. Reproducible research. Examples using open source software Madagascar: Finite Difference modeling for the wave equation, Reverse Time Migration. Conjugate Gradients and Least Squares Migration.

High-Performance Computing in C and C++. General strategies for efficient software development.

Shared memory: Multithreading with OPENMP.

Distributed memory and clusters. OPENMPI. Examples. Debugging, profiling, memory checking.

High-Performance Computing in Python, multithreading, profiling, debugging.

Collaborative programming. Source Control. GIT.

Introduction to programming for Graphics Processing Units (GPUs).
