Description

This course introduces the main historical themes that influenced the development of the modern world from roughly the seventeenth century to the late twentieth century. By doing so, students will appreciate how the present is often shaped by the past, and how ideas, culture, politics, conflict, economics, technology, and institutions have contributed to the construction of the "modern" globalized world.

Learning Outcomes

This course will familiarize students with important interpretations of world history and give them insight into the interconnectedness of the world and its history with the present. It will also develop their ability to interpret historical sources and make arguments within historical debates. Finally, it will further develop students' skills in analysis, source comprehension, communication, critical thinking, and argumentation.

Grading Policies

Grades will be marked out of a number based on the percentage weight of the assignment (thus, an assignment worth 20% of the overall grade, will be marked out of 20 points). Letter grades for each individual assignment will also be provided. **Late assignments** may be penalized up to the equivalent of one third of a letter grade per day. **Extensions** may be granted upon request. Assignments should be placed in the Dropbox on the course D2L on the day they are due.

Details on Methods of Assessment

Group Work: At the end of every week, students will discuss the weekly readings. Students will form into small groups to discuss questions about the sources they have read, before joining in a general class discussion. There will be eleven class discussions, participation in each is worth one percent of the final grade, for a maximum total of 10%. Participation will be assessed via the group work assignments. If you anticipate missing more than one group work, please let me know and alternative arrangements can be made, according to instructor discretion.

The Midterm examination will be written in class on Monday February 27, 2023. It will consist of identification questions and one essay question based on the course lectures and readings. More information will be provided by the instructor in class and on D2L.

Thesis and Bibliography: Students will be asked to submit an introductory paragraph, including a thesis statement, and a bibliography of at least eight *academic* sources (scholarly journal articles, books) for a research paper on a topic of their choice in consultation with the instructor. Encyclopedias, lecture notes, textbooks, websites, etc. are not scholarly sources and should not be used. This assignment will assess the student's ability to successfully formulate a research question, identify sources, and construct a thesis. It will also prepare them for completing the full research paper. This assignment is due March 6, 2023. Detailed instructions will be provided in class and on D2L.

Research Paper: Students will submit a research paper of approximately 2,000 words in

length on a topic of their choice in consultation with the instructor. It is highly recommended that this paper be based on the thesis and bibliography assignment. **This paper is due March 27, 2023.** Detailed instructions will be provided in class and on D2L.

Both the Thesis/Bibliography and Research Paper assignments should be uploaded, in Word or PDF formats, into the correct folder on D2L.

The Final Examination will follow the same format as the Midterm: identification questions and one essay question based on the course lectures and readings. **The exam will *not* be cumulative**, and will only cover material discussed after the midterm. This exam is scheduled by the Registrar.

Academic Integrity Statement

All work must be the student's own, done independently and without collaboration. Evidence to the contrary may be considered academic dishonesty and treated accordingly.

Please Note: Students are expected to reach the grade range to receive that letter grade (ie. to receive an A- a student will have earned an 80 or 3.7 in the course). Assume that there will be no rounding up unless a faculty member announces otherwise.

Writing

All written assignments and written exam responses are assessed partly on writing skills. Writing skills include surface correctness (grammar, punctuation, sentence structure, etc.) and general clarity and organization. Research papers must be properly documented according to the format described in *The History Student's Handbook*.

Academic Misconduct

Academic Misconduct refers to student behavior which compromises proper assessment of a student's academic activities and includes: cheating; fabrication; falsification; plagiarism; unauthorized assistance; failure to comply with an instructor's expectations regarding conduct required of students completing academic assessments in their courses; and failure to comply with exam regulations applied by the Registrar.

Plagiarism

Plagiarism occurs when students submit or present the ideas and/or writing of others as if they were their own or when they submit their own work to two different classes. Please see <u>The History Student's Handbook</u> for more details, but to summarize, plagiarism may take several forms:

- Failing to cite sources properly
- Submitting borrowed, purchased, and/or ghostwritten papers
- Submitting one's own work for more than one course without the permission of the instructor(s) involved
- Extensive paraphrasing of one or a few sources, even when referenced properly, unless the essay is a critical analysis of those works

Plagiarism is a serious academic offence, and written work that appears to contain plagiarized passages will not be graded. All such work will be reported to the Faculty of Art's associate deans of students who will apply the penalties specified in the university calendar.

Academic Accommodation

It is the student's responsibility to request academic accommodations according to the <u>Student Accommodations policy</u>. Students needing an accommodation based on disability or medical concerns should contact Student Accessibility Services (SAS) in accordance with the <u>Procedure for Accommodations for Students with Disabilities</u>. Students are advised that any research with human participants – including any interviewing (even with friends and family), opinion polling, or unobtrusive observation – must have the approval of the <u>Conjoint Faculties Research Ethics Board</u> or the <u>Conjoint Health Research Ethics Board</u>. In completing course requirements, students must not undertake any human subjects research without discussing their plans with the instructor, to determine if ethics approval is required. Some courses will include assignments that involve conducting research with human participants; in these cases, the instructor will have applied for and received ethics approval for the course assignment. The instructor will discuss the ethical requirements for the assignment with the students.

Instructor Intellectual Property

Course materials created by instructors (including presentations and posted notes, labs, case studies, assignments and exams) remain the intellectual property of the instructor. These materials may NOT be reproduced, redistributed or copied without the explicit consent of the instructor. The posting of course materials to third party websites such as note-sharing sites without permission is prohibited. Sharing of extracts of these course materials with other students enrolled in the course at the same time may be allowed under fair dealing.

Copyright Legislation

Media Recording for Study Purposes (Students)

Students who wish to audio record lectures for personal study purposes need to follow the guidelines outlined in <u>Section E.6 of the University Calendar</u>. Unless the audio recording of lectures is part of a student accessibility requirement, permission must be sought by the course instructor to audio record lectures.

Media recording for lesson capture

The instructor may use media recordings to capture the delivery of a lecture. These recordings are intended to be used for lecture capture only and will not be used for any other purpose. Recordings will be posted on D2L for student use and will normally be deleted at the end of term. Students are responsible for turning off their camera and/or microphone if they do not wish to be recorded.

Media recording for assessment of student learning

The instructor may use media recordings as part of the assessment of students. This may include but is not limited to classroom discussions, presentations, clinical practice, or skills testing that occur during the course. These recordings will be used for student assessment purposes only and

will not be shared or used for any other purpose. The recording will be destroyed as specified by retention rule 2000.01 "Examinations and Student Assignments."

Media recording for self-assessment of teaching practices

The instructor may use media recordings as a tool for self-assessment of their teaching practices. Although the recording device will be fixed on the instructor, it is possible that student participation in the course may be inadvertently captured. The recording will be destroyed as specified by retention rule 98.0011 "Draft Documents & Working Materials."
