Description

This course will examine the military history, primarily of the Western World, from the eighteenth century to the end of the Second World War, with some background context from the seventeenth century to set the stage for later developments. The course will focus on a number of thematic topics, including areas such as the relationship between war and politics, the social and cultural context of warfare, the role of technology, aspects of gender, the impact of propaganda, ideology, and regular and irregular forms of warfare.

Learning Outcomes

The goal of this course is to encourage students to think critically about military history in the past and apply those understandings to other aspects of historical understanding. Warfare can be seen as an integral part of the historical past and understanding its causes, courses, and consequences will be useful when considering other historical eras and topics.

Reading Material

The following books are required to read and are available in the Bookstore for purchase. Any other form of acquisition is acceptable (renting, eBook, library etc.)

Grading Policies

Grades will follow the Department grading system. If there is a question about a particular grade, students should discuss it with the person who graded it in the first instance. Extensions should be requested well before the assignment is due if possible.

Details on Methods of Assessment

The assignments in the course are designed to balance between written work and examinations. Assignments will build upon each other so that the skills developed in one assignment will be employed in the next.

Outline and Bibliography

Students will be asked to write an outline – with a thesis statement – of at least one page in length and, on a separate page, a bibliography of at least 10 sources (one of which must be a primary source). This assignment is designed to encourage students to begin the process of research for their term paper, but it is not a contract, as your topic may change.

Mid-term Examination

Mid-term examination will cover material discussed in the lectures and the readings.

Term Paper

Students will be asked to write a term paper on any subject relating to the course and the time period covered. This can follow the direction of the outline and bibliography but that is not required. Better essays will utilize primary documents and will demonstrate historical use of those documents. Length is to be 10-12 pages with standard margins, Times New Roman 12pt. font. Students should consult The History Student's Handbook for help.

Please Note: Students are expected to reach the grade range to receive that letter grade (ie. to receive an A- a student will have earned an 80 or 3.7 in the course). Assume that there will be no rounding up unless a faculty member announces otherwise.

Writing

All written assignments and written exam responses are assessed partly on writing skills. Writing skills include surface correctness (grammar, punctuation, sentence structure, etc.) and general clarity and organization. Research papers must be properly documented according to the format described in *The History Student's Handbook*.

Academic Misconduct

Academic Misconduct refers to student behavior which compromises proper assessment of a student's academic activities and includes: cheating; fabrication; falsification; plagiarism; unauthorized assistance; failure to comply with an instructor's expectations regarding conduct required of students completing academic assessments in their courses; and failure to comply with exam regulations applied by the Registrar.

Plagiarism

Plagiarism occurs when students submit or present the ideas and/or writing of others as if they were their own or when they submit their own work to two different classes. Please see <u>The History Student's Handbook</u> for more details, but to summarize, plagiarism may take several forms:

- Failing to cite sources properly
- Submitting borrowed, purchased, and/or ghostwritten papers
- Submitting one's own work for more than one course without the permission of the instructor(s) involved
- Extensive paraphrasing of one or a few sources, even when referenced properly, unless the essay is a critical analysis of those works

Plagiarism is a serious academic offence, and written work that appears to contain plagiarized passages will not be graded. All such work will be reported to the Faculty of Art's associate deans of students who will apply the penalties specified in the university calendar.

Academic Accommodation

It is the student's responsibility to request academic accommodations according to the <u>Student Accommodations policy</u>. Students needing an accommodation based on disability or medical concerns should contact Student Accessibility Services (SAS) in accordance with the <u>Procedure for Accommodations for Students with Disabilities</u>. Students are advised that any research with human participants – including any interviewing (even with friends and family), opinion polling, or unobtrusive observation – must have the approval of the <u>Conjoint Faculties Research Ethics Board</u> or the <u>Conjoint Health Research Ethics Board</u>. In completing course requirements, students must not undertake any human subjects research without discussing their plans with the instructor, to determine if ethics approval is required. Some courses will include assignments that involve conducting research with human participants; in these cases, the instructor will have applied for and received ethics approval for the course assignment. The instructor will discuss the ethical requirements for the assignment with the students.

Instructor Intellectual Property

Course materials created by instructors (including presentations and posted notes, labs, case studies, assignments and exams) remain the intellectual property of the instructor. These materials may NOT be reproduced, redistributed or copied without the explicit consent of the instructor. The posting of course materials to third party websites such as note-sharing sites without permission is prohibited. Sharing of extracts of these course materials with other students enrolled in the course at the same time may be allowed under fair dealing.

Copyright Legislation

Media Recording for Study Purposes (Students)

Students who wish to audio record lectures for personal study purposes need to follow the guidelines outlined in <u>Section E.6 of the University Calendar</u>. Media recording for lesson capture

The instructor may use media recordings to capture the delivery of a lecture. These recordings are intended to be used for lecture capture only and will not be used for any other purpose. Recordings will be posted on D2L for student use and will normally be deleted at the end of term. Students are responsible for turning off their camera and/or microphone if they do not wish to be recorded.

Media recording for assessment of student learning

The instructor may use media recordings as part of the assessment of students. This may include but is not limited to classroom discussions, presentations, clinical practice, or skills testing that occur during the course. These recordings will be used for student assessment purposes only and will not be shared or used for any other purpose. The recording will be destroyed as specified by retention rule 2000.01 "Examinations and Student Assignments".

Media recording for self-assessment of teaching practices

The instructor may use media recordings as a tool for self-assessment of their teaching practices. Although the recording device will be fixed on the instructor, it is possible that student participation in the course may be inadvertently captured. The recording will be destroyed as specified by <u>retention rule 98.0011</u> "Draft Documents & Working Materials".
