Course Description:

History 491.01 is the first part of a two-part sequence in the history of international relations and covers the "Long 19th Century" from the French Revolution to the end of the First World War. The course evaluates the role of individuals, groups, institutions, and publics in the process of foreign policy formulation and examines how different methodological approaches, like culture, ideology, and the gendering of people and nations, influence historical interpretations.

Course Outcomes:

- Explain the key developments in U.S. history in the period 1893-1945
- Critically read and assess primary and secondary literature and situate arguments within broader historical debates
- Debate historical problems by engaging with other students and scholarship
- Develop research, writing, and analytical skills through historical inquiry
- Communicate ideas and understandings in written work and class discussion

Research papers must be properly documented according to the format described in the History Student's Handbook.
