### Course Description:

Fundamental principles of creating an effective learning environment in the school Physical Education Alternative Environments setting (K to Grade 12).

The course is designed to provide a basic knowledge & skills related to the effective teaching & delivery of physical education content in a variety of alternative activity environments. Since there will be sessions involving participation in a variety of physical activities appropriate clothing should be worn.

### Course Objectives:

#### The student will:

- 1. be conversant with information related to the philosophy, terminology, concepts & scope of physical education activity in alternative environments.
- 2. be conversant with the concept of risk, with methods for appropriately analyzing & dealing with risk management scenarios.
- 3. be conversant with skill analysis related to effective skill performance, including related biomechanical principles, & effective error detection & correction feedback strategies related to a variety of student learning stages.
- 4. be conversant with integrating physical activity skills into effective annual, unit, & daily lesson plans.
- 5. be conversant with appropriate alternative environment performance assessment techniques.
- 6. have the opportunity to participate in canoeing classes, as a model teaching scenario.
