Course Outcomes:

- Calculate present values of annuities and insurances on independent and dependent multiple lives.
- Calculate present values and cash flows of Universal insurances and participating insurances
- Describe and compare defined benefits plans and defined contribution plans
- Identify and interpret the common states and decrements for pension plans, and the parametric and tabular models, including Markov chain models, associated with these decrements
- Calculate and interpret the actuarial accrued liability and the normal cost for defined benefit plans under projected unit credit (PUC) and traditional unit credit (TUC) funding.
- Calculate the impact of changing mortality, expenses and investment assumptions for all the products that was discussed in the course.
