A hands-on introduction to basic coding skills, including core programming concepts and the fundamentals of reading, writing, and executing code – with a focus on data manipulation. Emphasizes important tools and practices for programming with data, including development environments, source control, and debugging.

- o Demonstrate the ability to solve problems logically and systematically.
- o Demonstrate fundamental programming skills, such as effective use of variables, expressions, conditionals, loops, functions, lists, and dictionaries.
- o Create programs to load data from files, transform data, and output data to files.
- o Create programs to generate visualizations.
- o Create programs using an integrated development environment.
- o Use a debugger to identify and fix simple errors in code.
- o Use a source control repository to track and manage code changes.
