Course Outcomes

Multiple Linear Regression

1. Model the multiple linear relationship between a response variable (Y) and all explanatory variables (both categorical and numerical variable) with interaction terms. Interpret model parameter estimates, construct confidence intervals for regression coefficients, evaluate model fits by (R²adj and RMSE).

2. Visualize correlations between a response variable (Y) and all explanatory variables (X) by graphs (scatter plot, residual plot) to assess model validity. Check the multi -linearity problem of a MLR model.

3. Use Stepwise/Forward/Backward variable selection procedures to identify the most significant subset of predictor variables that contribute to the explanation of the variation Y.

4. Check all assumptions by residual plots and statistical tests (testing for non constant variance, testing for normality) and outliers.

5. Apply transformations (logarithmic transformations, power functions) to some/all of the response variable and the predictor variables to create a better model.

6. Once the fitted model exists, predict the response variable at a certain level of the explanatory variables.

7. Use open data set to build the best fitted model, write reports for a group research project. Deliver professional presentations and discuss group research project results with the entire class.

Logistic Regression

8. Model the logistic regression for a binary response variable with a set of independent variables (both categorical and numerical variable), interpret model parameter estimates in terms of odd ratio, construct confidence intervals for logistic regression coefficients

9. Visualize correlations between a response variable (Y) and all explanatory variables (X) by graphs.

10. Check all necessary assumptions by residual plots, multicollinearity and outliers.

11. Predict the probability of response variable P(Y=1|X) at a certain level of the explanatory variables

Experimental Design

12. Understand methods of sampling from population, definitions of Design of Experiment, and some concepts of DOE.

13. Test for difference in averages between levels for one factor design (complete randomized design), block design, two factor factorial design and nested design, use pairwise comparison procedures for comparing in pairs to determine which means are different from others, discuss the output in class and make conclusions.

14. Check all assumptions by residual plots and statistical tests (testing for non constant variance, testing for normality) for a model.

15. Apply non-parametric test when some assumptions are not satisfied.

16. Learn to use statistical software R to analyse a model, write some R codes, and apply R functions to interpret results from outputs.
