Exam 1, Exam 2 and the Final Exam will be made available over a period spanning the scheduled class time on the given dates. Students with a time conflict on those dates must contact the instructor well in advance of the exam date.

Additional time will be granted to SAS students, and other accommodation will be done on a case-by-case basis in case of conflict or student location in different time zones.

Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. The student's grade for each component listed above will be combined with the

indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade.
