#### **Integrated Design Studio Based Learning**

#### 1) Mobile App Active Learning

A mobile application (available though mobile phones or regular computer browsers) provides a summary of the material in short pages, each with a short right/wrong interactive randomized question to gauge student understanding of that material. Up to 10% will be awarded based on the proportion of successfully completed questions.

#### 2) Online Assignments

There are 10 online assignments each with its own a due date, but available for at least 1 week after covering the material.

#### 3) Online Examinations

Each examination is asynchronous and designed for 100 minutes, and an additional 50% time buffer is granted for a

total of 150 minutes (2  $\frac{1}{2}$  hours) to accommodate any technical or other online examination issues. Students can start anytime after 6pm of the opening day and submitted before 6pm of the closing day. Note that the exam is due at 6pm of the closing day and hence everyone must start before 3:30pm to benefit from the full 150 minutes allocation.

Additional time will be granted to SAS students, and other accommodation will be done on a case-by-case basis. All students

need to contact the coordinator at least 14 days prior to the examination to arrange for accommodations.

Each piece of work (active learning, assignments and examinations) submitted by the student will be assigned a grade. The student's grade for each component listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade.

Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. The student's grade for each component listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade.

This course will have a final exam that will be scheduled by the Registrar. The Final Examination Schedule will be published by the Registrar's Office approximately one month after the start of the term. The final exam for this course will be designed to be completed within 1.66 hours.

The final exam will be administered using an on-line platform. Per section of the online Academic Calendar, timed final exams administered using an on-line platform, such as D2L, will be available on the platform. Due to the scheduling of the final exams, the additional time will be added to **the end** of the registrar scheduled **synchronous** exam to support students. This way, your exam schedule accurately reflects the **start time** of the exam for any **synchronous** exams. E.g. If a **synchronous** exam is designed for 2 hours and the final exam is

scheduled from 9-11am in your student centre, the additional time will be added to the **end** time of the **synchronous** exam. This means that if the exam has a 1 hour buffer time, a synchronous exam would start at 9 am and finish at 12pm.

• the latest you should start an asynchronous exam would be 8 am in order to be able to submit the exam at 11am and have the full 3 hours.

Access to Lyryx online homework for no charge is also available at the TFDL, but currently only on Mac computers; access may be available sporadically in ES 160.
