Course Outcomes:

- o Explore the relationship between key linear algebra concepts and their geometric representation.
- o Seek to apply linear algebra techniques to a variety of practical problems.
- o Read and create proofs of mathematical statements about topics covered in the course.
- o State all of the technical definitions covered in the course (such as a vector space, span, independence, dimension, linear transformation, kernel, image, and other terms)
- o State all of the relevant theorems covered in the course
- o Use these definitions and theorems from memory to construct solutions to problems and/or proofs.
- o Verify that an abstract mathematical object satisfies a given definition, or is a counterexample
- o Analyze a finite dimensional vector space and its properties, including the basis structure of vector spaces
- o Understand the concept of a linear transformation as a map from one vector space to another, and to be able to construct such maps given a basis of the domain
- o Use the Gram-Schmidt process to produce an orthonormal basis
