**Online Delivery Details:**

This course does not follow a scheduled meeting pattern.

This course has a registrar scheduled, asynchronous final exam. The writing time is 3 hours + 50% buffer time, but the exam can be written any time in a 24-hour window.

**The instructor will record live lectures 3 times per week during the scheduled MWF 11-11:50 time-slot. These classes will contain a blend of conventional lectures and exercises, complemented by reading material from the textbook. Since the lectures will be recorded, you are not required to attend live but it is encouraged.**

3. **Grading:**

Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. The student's grade for each component listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade.

The conversion between a percentage grade and letter grade is as follows.

This course will have a final exam that will be scheduled by the Registrar. [The Final Examination Schedule](#) will be published by the Registrar's Office approximately one month after the start of the term. The final exam for this course will be designed to be completed within 3 hours.

The final exam will be administered using an on-line platform. Per section [G.5](#) of the online Academic Calendar, timed final exams administered using an on-line platform, such as D2L, will be available on the platform. Due to the scheduling of the final exams, the additional time will be added to **the end** of the registrar scheduled **synchronous** exam to support students. This way, your exam schedule accurately reflects the **start time** of the exam for any **synchronous** exams. E.g. If a **synchronous** exam is designed for 2 hours and the final exam is scheduled from 9-11am in your student centre, the additional time will be added to the **end** time of the **synchronous** exam. This means that if the exam has a 1 hour buffer time, a synchronous exam would start at 9 am and finish at 12pm. - **updated April 6, 2021**

- the latest you should start an asynchronous exam would be 8 am in order to be able to submit the exam at 11am and have the full 3 hours.

#### **Course Outcomes:**

- apply basic proof techniques, including direct proofs, proofs by contradiction and mathematical induction to rigorously prove results about abstract and concrete algebraic objects
- carry out manipulations on concrete algebraic objects, including sets, maps, permutations, integers and polynomials
- apply algorithmic techniques to integers and polynomials, including Euclidean division, greatest common divisor computation, modular arithmetic and solving systems of linear congruences
- build new structures by applying algebraic constructions, including products and quotients, to basic algebraic objects
- describe and prove fundamental facts about and properties of groups, rings and homomorphisms
- demonstrate proficiency in applying structural properties of groups, rings and homomorphisms to solve concrete problems, including applications arising in other areas of mathematics such as geometry and number theory
